## 1. Introduction

- Apollo Property Group Pty Ltd (ACN 151 819 895) is committed to responsible privacy practices and to complying with the Privacy Principles contained in the Privacy Act 1988 (Cth) ("Privacy Act") to the extent they apply to us and the requirements of ISO/IEC 27001:2022/COR 2:2022.
- This Privacy Policy sets out our policies on the management of personal information including how we collect personal information, the purposes for which we use this information, and to whom this information is disclosed.

### 2. What is personal information?

• In this Privacy Policy, "personal information" has the meaning set out in the Privacy Act. Essentially, personal information is information or an opinion about an individual who is reasonably identifiable.

### 3. What types of personal information do we collect?

- The types of personal information we collect from you depend on the circumstances in which the information is collected.
- We may collect contact details including your name, address, email address, phone numbers and your date of birth / age. We may also collect answers you provide to questions we ask and other information in relation to your dealings with us.
- If you apply for employment with us, we may also collect information for the purpose of considering your application including your qualifications and resume as well as reference information from your nominated referees.
- If you are an individual contractor to us, we may also collect information relevant to your engagement with us including qualifications, work history, resume, reference information from your nominated referees, bank details, feedback from supervisors and training records.
- Except as described in this section, we do not generally require you to disclose any sensitive information (e.g. details of race, religious belief, sexual orientation or membership of a trade union) to us. If you do provide us with sensitive information for any reason, you consent to us collecting that information and using and disclosing that information for the purpose for which you disclosed it to us and as permitted by the Privacy Act and other relevant laws.
- In addition to the types of personal information identified above, we may collect personal information as otherwise permitted or required by law.

## 4. How do we collect your personal information?

- We collect personal information in a number of ways. The most common ways we collect your personal information are:
  - a) Directly from you when you provide it to us;
  - b) Via our social media
  - c) From publicly available sources;
  - d) From third parties (for example, from referees if you apply for a position as an employee or contractor with us).

## 5. For what purposes do we collect, use and disclose your personal information?

- The purposes for which we use and disclose your personal information will depend on the circumstances in which we collect it. Whenever practical we endeavour to inform you why we are collecting your personal information, how we intend to use that information and to whom we intend to disclose it at the time we collect your personal information.
- We may use or disclose your personal information:
  - a) For the purposes for which we collected it (and related purposes which would be reasonably expected by you);
  - b) For other purposes to which you have consented; and
  - c) As otherwise authorised or required by law.
- In general, we collect, use, and disclose your personal information so that we can do business together and for purposes connected with our business operations.
  - a) Some of the specific purposes for which we collect, use, and disclose personal information are:
  - b) To respond to you if you have requested information (including via an email or other correspondence you send to us).
  - c) To provide goods or services to you or to receive goods or services from you.
  - d) To enable you to use our apps and other applications that you download.
  - e) To improve our goods and services.
  - f) To verify your identity, licence and or qualifications to permit you to participate in work specific activities such as high risk activities or operating vehicles.
  - g) To consider you for a job with us (whether as an employee or contractor) or in the context of other relationships with us.
  - h) To address any issues or complaints that we or you have regarding our relationship.
  - i) To contact you regarding the above, including via electronic messaging such as SMS and email, by mail, by phone or in any other lawful manner.

## 6. To whom do we disclose personal information?

- We may disclose your personal information to third parties in connection with the purposes described in section 5 of this Privacy Policy.
- This may include disclosing your personal information to the following types of third parties:
  - a) Our employees and related bodies corporate;
  - b) Our contractors and other third parties that provide goods and services to us (including website and data hosting providers, and other suppliers);
  - c) Our accountants, insurers, lawyers, auditors and other professional advisers and agents;
  - d) Payment system operators;
  - e) If you are an individual contractor to us or a prospective employee, to our related companies and HR related service providers (e.g. Recruiting agencies)
  - f) Any third parties to whom you have directed or permitted us to disclose your personal information (e.g. referees).
  - g) In the event that we or any of our assets (including any agreement we may have with you) may be acquired, transferred or assigned or considered for acquisition, transfer or assignment by a third party, that third party and its advisors;
  - h) Third parties that require the information for law enforcement or to prevent a serious threat to public safety; and
  - i) Otherwise as permitted or required by law.
- Where we disclose your personal information to third parties, we will use reasonable efforts to ensure that such third parties only use your personal information as reasonably required for the purpose we disclosed it to them and in a manner consistent with the Privacy Principles under the Privacy Act.

- Nothing in this Privacy Policy restricts, excludes, or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).
- Please notify us immediately if you become aware of any breach of security.

#### 8. Accuracy of the personal information we hold

- We try to maintain your personal information as accurately as reasonably possible. We rely on the accuracy of personal information as provided to us both directly (from you) and indirectly.
- We encourage you to contact us if the personal information we hold about you is incorrect or to notify us of a change in your personal information. Our contact details are set out in section 15 of this Privacy Policy.

#### 9. Links, cookies and use of our websites and applications

- We may use "cookies" and similar technology on our websites and in other technology applications. The
  use of such technologies is an industry standard and helps to monitor the effectiveness of advertising and
  how visitors use our websites/applications. We may use such technologies to generate statistics, measure
  your activity, improve the usefulness of our websites/applications and to enhance the "customer"
  experience.
- If you prefer not to receive cookies, you can adjust your Internet browser to refuse cookies or to warn you when cookies are being used. However, our websites may not function properly or optimally if cookies have been turned off.

#### 10. How can you access and correct personal information we hold about you?

- You may seek access to personal information which we hold about you by contacting us as described in section 15 of this Privacy Policy. We will provide access to that information in accordance with the Privacy Act, subject to certain exemptions which may apply.
- If you become aware that any personal information, we hold about you is incorrect or if you wish to update your information, please contact us (see section 15 of this Privacy Policy).

#### 11. Queries, comments and complaints about our handling of personal information

- We will take any privacy complaint seriously and any complaint will be assessed with the aim of resolving any issue in a timely and efficient manner. We request that you cooperate with us during this process and provide us with any relevant information that we may need.
- If you are not satisfied with the outcome of our assessment of your complaint, you may wish to contact the Office of the Australian Information Commissioner.
