3. Understandable

- [/] The website utilizes clear and simple language, making it more accessible to a broader audience, including people with cognitive disabilities.
- [\(\rightarrow \)] The website's navigation and structure are consistent across pages, reducing confusion for users with cognitive impairments.

4. Robust

[/] The website's code follows best practices and uses valid HTML and CSS, contributing to its overall robustness and compatibility with a wide range of assistive technologies.

Additional Findings

- [\(\lambda \)] The website's responsive design ensures that it adapts well to different screen sizes and devices, benefiting users with varying abilities and using various assistive technologies.
- [/] The website includes an accessibility statement that outlines its commitment to providing an inclusive experience and offers contact information for users to report accessibility concerns.

Recommendations

Periodic accessibility audits and user testing with people with disabilities are encouraged to identify and address any potential accessibility barriers that may arise as the website evolves.
