15. Our services

Each payment is voluntary and is not forced in the system.

The user can purchase the Creator's package for the amount of 20 USD and get LiveDiff 20 VOTES with which he can vote for the development of the platform.

The user can purchase a Creator's package for the amount of 500 USD and get LiveDiff 500 VOTES with which he can vote for the development of the platform and also get VIP privileges in the form of opening functionalities

- Access to Bonus and Rewards, where one can get a reward for activity on the platform
- Access to Exclusive Access (functionality will be unlocked in the next phase of the project)
- Access to Priority Influence (feature will be unlocked once the Posts functionality is completed)
- Access to Shareholder Priviledges, the user gains a DIFF TOKEN along with VOTES, the use of which will be addressed in a future phase of the project

The user can purchase the Creator's package for any amount up to a maximum of 20 000 USD for 1 payment. In this case the user gets 1 VOTE for 1 USD

Once the user purchases packages worth 500 USD for the duration of the platform, he/she will receive access to all VIP bonus categories.
