## TERMS

Arcturus Studios US, Inc. (“**Arcturus**”, “**we**”, “**us**”) has developed proprietary software that is licensed for use as a capture-agnostic post-production platform for volumetric video (“**HoloSuite Software**”). Subscribers to our HoloSuite Software may upload, store, create, process, share or otherwise make available text, information, data, applications or material, such as audio files, video files, electronic documents, or images using the HoloSuite Software (“**Content**”). Such Content can be shared with non-subscribers to the HoloSuite Software (“**End Users**”) and accessed, viewed and listened to by third parties using Arcturus’ proprietary HoloSuite Player software (“**Player**”).

This HoloSuite Player Software Distribution License (“**License**”) describes the rights and obligations that apply to the Player. It allows you to distribute a copy of the Player to an End User so that the End User can enable third parties to access, view or listen to Content. By accepting this License, or reproducing or distributing the Player, you confirm your acceptance of this License and your agreement to be a party to this binding contract with Arcturus. If you do not agree, you do not have the right to reproduce or distribute the Player.

You agree to this License on behalf of the company or other legal entity for which you are acting (for example, as an employee or contractor) or, if there is no company or legal entity, on behalf of yourself as an individual (in either case, “**You**” or “**you**”). You represent and warrant that you have the right and authority (as well as the capacity — for example, you are of sufficient legal age) to act on behalf of and bind such entity (if any) and yourself.

## 1. DISTRIBUTION OF PLAYER

- 1.1 **Application.** This Licence applies to third parties that have developed, own, manage, or run websites or applications where Content may be shared, disclosed, distributed, transferred, rented, leased, loaned, sublicensed, sold or otherwise made available to End Users.
- 1.2 **License.** Subject to your compliance with this License, we grant you a non-exclusive, non-sublicensable, non-transferable license to reproduce an unaltered version of the Player and Distribute such unaltered copy of the Player to End Users for the sole purpose of allowing the End User to facilitate access to, viewing of or listening to Content by third parties on the End Users’ website or application. **“Distribute”** means to share, send, transmit, disclose, display, publish or otherwise provide or make available the Player by way of a zipped software install file or embedded in an application or on your website, or to direct End Users to download the Player from the Arcturus website or contact the Arcturus Customer Success team for access.
- 1.3 **Exclusions.** This License does not apply to:
- (a) Installation of or access to the Player, which shall be governed by the Player Software End User License Agreement;
  - (b) Arcturus subscription-based services or software, which shall be governed by the Arcturus General Terms of Use and any Additional Terms; or
  - (c) any Arcturus professional services including custom software development, integration, implementation or other consulting services, which shall be governed by a separate master services agreement.
- 1.4 **Arcturus Intellectual Property.** The Player is licensed, not sold, to you. We (and our licensors) remain the sole owner of all right, title, and interest, including all intellectual property (**“IP”**) rights, in the Player. **“IP”** includes copyrights, patents, utility models, trademarks, service marks, registered designs, moral rights, design rights (whether registered or unregistered), technical information, know-how, trade secrets, database rights, semiconductor topography rights, business names and logos, computer data, generic rights, proprietary information rights and all other similar proprietary rights (and all applications and rights to apply for registration or protection of any of the foregoing) as may exist anywhere in the world. Except as stated in this License, we do not grant you any IP rights in respect to the items in the Player. We reserve all rights not granted under this License.
- 1.5 **Recognition. To the extent that you embed the Player in an application or on your website, you must recognize Arcturus as the owner of the Player and insert the text “Powered by HoloSuite” in a prominent location on the application or website.**
- 1.6 **End User Licence:** Installation of, and access to, the Player by all End Users is subject to their acceptance of, and agreement to comply with, the end user license agreement applicable to the Player available at <https://arcturus.studio/software-license-agreements/> (**“EULA”**). Where you Distribute the Player to an End User, you must also provide the End User with a hyperlink to the

EULA and notify the End User that installation of, and access to, the Player is subject to their compliance with the terms set out in the EULA.

- 1.7 **Third Party Content.** The Player is used by third parties to upload, store, create, process, share or otherwise make available Content. Arcturus does not control, endorse or accept responsibility for any Content (including the accuracy, completeness, appropriateness, or lawfulness of such Content). Arcturus assumes no liability whatsoever for any claims or losses arising out of or otherwise relating to your or any End User's access to or use of any Content.

## 2. DISTRIBUTOR CONDUCT

### 2.1 **Responsible Use.** You must not:

- (a) reproduce or Distribute the Player without, or in violation of, this License;
- (b) charge End Users any fee to receive, install or access the Player;
- (c) rent, lease, lend, sublicense, sell or otherwise exploit the Player (or any items or rights therein) for any commercial purpose;
- (d) Distribute a version of the Player that has been edited, enhanced, altered, arranged, modified, developed, ported, adapted, translated, or created as a derivative work;
- (e) reverse engineer (including but not limited to monitoring or tracking the inputs and outputs flowing through a system or an application in order to recreate that system), decompile, disassemble, or otherwise attempt to discover, the source code, data representations or underlying algorithms, processes, methods, and any other portion of the Player;
- (f) reproduce or Distribute the Player by any means other than the interface we provide or authorize, or attempt to do so;
- (g) circumvent any reproduction or Distribution restrictions, or technological measures, put into place to control access to or prevent certain uses of the Player;
- (h) impersonate any person or entity, or falsely state or otherwise misrepresent your affiliation with any person or entity;
- (i) disable, impair, destroy, manipulate or disrupt the Player, or attempt to do so;
- (j) remove, minimize, alter, obscure, or modify any watermarks, labels, marks or other legal or proprietary notices on or in the Player;

- (k) upload, store, create, process, share or otherwise make available any code that contains any viruses, malicious code, malware, or any components designed to harm or limit the functionality of the Player;
- (l) manipulate or otherwise display the Player by using framing or similar navigational technology;
- (m) use any data mining or similar data gathering and extraction methods in connection with the Player, including data scraping for machine learning or other purposes;
- (n) disrupt, interfere with, or inhibit any End User from installing or accessing the Player; or
- (o) reproduce or Distribute the Player in any way that is illegal, unlawful or prohibited, or for any purpose that is in violation or breach of any applicable law or regulation.

2.2 **Trade Sanctions and Export Control Compliance.** The Player, and your reproduction or Distribution of it, is subject to laws, restrictions, and regulations of the United States and other jurisdictions that: (a) govern the import, export, and use of the Player; and (b) may prohibit us from granting the rights set out in this Licence or providing the Player to you without notice. By reproducing or Distributing the Player, you agree to comply with all such laws, restrictions, and regulations, and you warrant that you are not prohibited from reproducing or Distributing the Player by the laws of any jurisdiction.

2.3 **Availability.** Reproduction or Distribution of the Player (or certain features of the Player) in certain countries may be blocked by us or foreign governments. It is your responsibility to make sure your reproduction or Distribution of the Player is legal or available where you do so. The Player is not available in all languages.

### 3. DISCLAIMERS OF WARRANTIES

3.1 **THE PLAYER IS PROVIDED "AS-IS." TO THE MAXIMUM EXTENT PERMITTED BY LAW, WE DISCLAIM ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF NON-INFRINGEMENT, MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE. WE MAKE NO COMMITMENTS ABOUT THE PLAYER. WE FURTHER DISCLAIM ANY WARRANTY THAT: (A) THE PLAYER WILL MEET YOUR OR ANY END USERS' REQUIREMENTS OR WILL BE CONSTANTLY AVAILABLE, UNINTERRUPTED, TIMELY, SECURE, OR ERROR-FREE; (B) THE QUALITY OF THE PLAYER WILL MEET YOUR EXPECTATIONS; OR (C) ANY ERRORS OR DEFECTS IN THE PLAYER WILL BE CORRECTED. ARCTURUS DOES NOT PROVIDE ANY SUPPORT SERVICES FOR THE PLAYER.**

3.2 **WE SPECIFICALLY DISCLAIM ALL LIABILITY FOR ANY ACTIONS RESULTING FROM YOUR REPRODUCTION OR DISTRIBUTION OF THE PLAYER. YOU MAY REPRODUCE OR DISTRIBUTE THE PLAYER AT YOUR OWN DISCRETION AND RISK, AND YOU ARE SOLELY RESPONSIBLE FOR ANY DAMAGE TO YOUR COMPUTER SYSTEM OR LOSS OR CORRUPTION OF DATA THAT RESULTS THEREFROM.**

#### **4. INDEMNITY AND LIMITATION OF LIABILITY**

4.1 **You will indemnify us and our subsidiaries, affiliates, officers, agents, employees, partners, and licensors from any claim, demand, loss, or damage, including reasonable attorneys' fees, arising out of or related to your reproduction or Distribution of the Player, or your violation of this License. We have the right to control the defense of any claim, action, or matter subject to indemnification by you with counsel of our own choosing. You must fully cooperate with us in the defense of any such claim, action, or matter.**

4.2 **We are not liable to you or anyone else for any special, incidental, indirect, consequential, moral, exemplary or punitive damages whatsoever, regardless of cause, including losses and damages: (a) resulting from loss of use, data, reputation, revenue, or profits; (b) based on any theory of liability, including breach of contract or warranty, negligence, or other tortious action; or (c) arising out of or in connection with your reproduction or Distribution of the Player.**

4.3 **Our total liability in any matter arising out of or related to this License is limited to the greater of: (a) U.S. \$5; or (b) the aggregate amount of any fees you paid for the rights set out in this License during the three-month period preceding the event giving rise to the liability.**

4.4 **This License sets forth the entire liability of Arcturus and its affiliates as well as your exclusive remedy with respect to reproduction and Distribution of the Player. The limitations and exclusions in this Section 4 (Indemnity and Limitation of Liability) apply to the maximum extent permitted by law even if: (a) a remedy does not fully compensate you for any losses or fails of its essential purpose; or (b) we knew or should have known about the possibility of damages.**

#### **5. TERMINATION**

5.1 **Commencement of Licence.** This License is effective from the earlier of the date you receive or have access to a copy of the Player from us. You are under no obligation to reproduce or Distribute the Player to any End User and may stop doing so at any time.

5.2 **Termination.** Without prejudice to any other rights that we may have under this License or at law, we may terminate your rights under this License immediately if you fail to comply with any of its terms. Upon termination, you must stop all reproduction

or Distribution of the Player and delete all copies from your computer systems. We may also limit or disable your ability to reproduce or Distribute the Player in our discretion without notice.

- 5.3 **Survival.** Any provisions that by their nature continue and survive will survive any termination of this License, including your indemnification obligations, our warranty disclaimers and limitations of liabilities, and dispute resolution provisions stated in this License.

## 6. MISCELLANEOUS

- 6.1 **Notice.** Notices in connection with this License must be in writing and sent by email, pre-paid postal service, or a delivery service (such as UPS, FedEx or DHL). Notices from Arcturus to you will be effective: (a) in the case of notices by email, one (1) day after sending to the email address provided to Arcturus; or (b) in the case of notices by mail or delivery service, five (5) days after sending by regular post or delivery service to the address provided to Arcturus. You hereby consent to service of process being effected on you by registered mail sent to the last address known by Arcturus if so permitted by applicable law. Notices from you to Arcturus will be effective: (c) in the case of notices by email, one (1) day after sending to (and receipt by Arcturus at) [contact@arcturus.studio](mailto:contact@arcturus.studio); or (d) in the case of notices by mail or delivery service, when received by Arcturus at Arcturus Studios Holdings, Inc., 9290 Civic Center Drive, Beverly Hills CA 90210, Attention: Copyright Agent.
- 6.2 **Choice of Law.** This License is governed by and construed in accordance with the laws of the State of California (and, to the extent controlling, the federal laws of the United States). The laws of such jurisdictions shall govern without reference to the conflicts-of-laws rules thereof. The UN Convention on Contracts for the International Sale of Goods and the Uniform Computer Information Transaction Act shall not apply to (and are excluded from the laws governing) this License. In addition, you agree that any claim, action or dispute arising under or relating to this License will be brought exclusively in (and the parties will be subject to the exclusive jurisdiction of) the Superior Court of the State of California, County of Marin, or the United States District Court for the Northern District of California in San Francisco. Nothing in the foregoing will prevent Arcturus from bringing an action for infringement of IP rights in any country where such infringement is alleged to occur. You may only resolve disputes with us on an individual basis, and you may not bring a claim as a plaintiff or a class member in a class, consolidated, or representative action.
- 6.3 **Injunctive Relief.** If you are in violation of this License, you agree that we are entitled to apply for injunctive remedies (or an equivalent type of urgent legal relief) in any jurisdiction.
- 6.4 **Non-Assignment.** You may not assign or otherwise transfer this License or your rights and obligations under this License, in whole or in part, without our written consent, and any such attempt will be void. We may transfer our rights under this License to a third party.

- 6.5 **Severability.** If any provision of this License is held invalid or unenforceable for any reason, the remainder of this License will continue in full force and effect.
- 6.6 **No Waiver.** Our failure to enforce or exercise any provision of this License is not a waiver of that provision.
- 6.7 **Headings.** Headings used in this License are provided for convenience only and will not be used to construe meaning or intent.
- 6.8 **Entire Agreement.** This License constitutes the entire agreement between you and Arcturus (and merge and supersede any prior or contemporaneous agreements, discussions, communications, representations, warranties, advertising or understandings) with respect to the subject matter hereof.
- 6.9 **Updates to License.** We may make changes to this License from time to time, and if we do, we will notify you by revising the date at the top of this License. You should check our website regularly for any changes to this License. Unless otherwise noted, the amended Terms will be effective immediately, and your continued reproduction or Distribution of our Player will confirm your acceptance of the changes. If you do not agree to the amended License, you must stop using our Player.
- 6.10 **English Version.** The English version of this License will be the version used when interpreting or construing this License.
