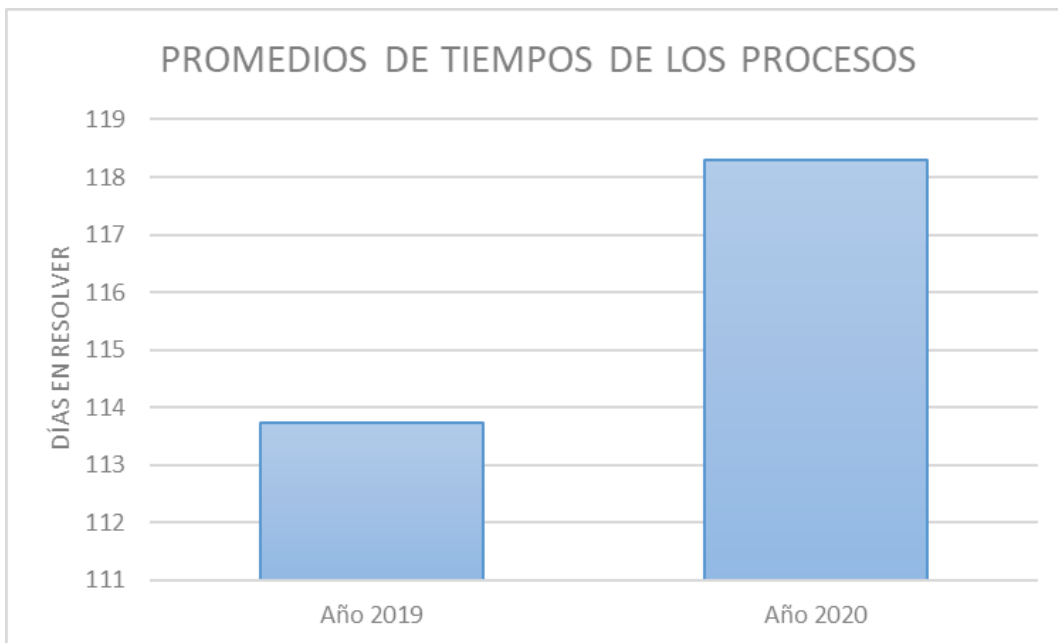








Comparación de promedios por año, del número de días que tomó resolver el proceso:
