After this deadline, training can no longer be cancelled or postponed. Assessments are subject to BPP's Extenuating Circumstances policy in the event candidates are unable to attend.

Candidates may request reasonable academic adjustments to be implemented for their assessments/studies through the Learning Support team. All supporting evidence must be submitted to the Learning Support team at least FIVE weeks prior to their first assessment date. Learning Support Agreements ("LSA's") must be final and confirmed at least ONE month before the first assessment take place. Continuing candidates who require adjustments should confirm with their learning support advisor that their LSA remains in place for their next assessments.
