## DIRECTIONS

**ADD** water to a 32 fl. oz. container. **DROP** in one POD for everyday degreasing and cleaning or two PODS for tough, caked-on grease and dirt. **WAIT** at least 1 minute for EZ-POD(S) to begin dissolving. EZ-PODS dissolve faster in warm water. **SHAKE or STIR** until EZ-POD(S) completely dissolve. **SPRAY** onto surface to be degreased, then remove. For tough, caked-on grease and dirt, allow the solution to set for a few minutes, then wipe off or rinse with water. For use in food-processing facility, rinse with potable water. Repeat if necessary.
