The permanently attached Smart Straw® Sprays 2 Ways® delivery system allows for pinpoint application or a wider spray, giving you different options to fit the job. The compact 5.5 oz can is easy to hold and maneuver to reach small areas and tight spots.

Safe for use on most plastics¹, rubber and metals, including copper steel, galvanized steel, brass, magnesium, nickel, tin plate, titanium and zinc, when used as directed. If unsure, test on a small area first.

DIRECTIONS

Shut off all power and allow any hot surfaces to cool. Make sure all stored power is drained from the system. Shake can well before each spray. Flip straw up for pinpoint stream or down for wide angle spray. Hold can 6 to 8 inches away from the surface and spray directly on to the electronic device or circuit board to eliminate and remove any contaminants that may cause loss of electrical contact. Tilt surface while cleaning and allow any excess cleaner to run off. Allow product to dry completely and thoroughly vent the system before restoring power.

STORAGE

Store in a cool, well-ventilated area, away from incompatible materials. Do not store above 120°F or in direct sunlight. U.F.C (NFPA 30B) Level 1 Aerosol. Store away from oxidizers.

DANGER!
