This notice provides you with information on a change to Child Care Super and GuildPension fees and costs. The change comes into effect on 1 May 2024.

## We've made changes to our fees

## Reducing part of our administration fees for all products

We're committed to providing a fee structure that helps protect the account balances of our members. That's why we have lowered our dollar-based administration fees across all products effective 1 May 2024 from \$104 p.a. to \$88.40 p.a. for our MySuper, MyMix, and GuildPension investment options.

# Investment Fees and Costs or Transaction Costs have changed for some products

Investment Fees and Costs and Transaction Costs have changed due to estimates of the underlying costs paid in a 12 month period (relying on available data as at the preparation of this notice). These fees are deducted from the investment option daily before the unit price and not directly from your account. The fee changes impact some of our investment options and are summarised below.
