

Future Council Film Screening – Climate Action Week Sydney Terms and Conditions

1. Acceptance of Terms

1.1 Information on how to register for tickets to the *Future Council Film Screening – Climate Action Week Sydney* (the “Event”) forms part of these terms and conditions.

1.2 Registration for, or attendance at, this Event constitutes acceptance of these terms and conditions.

2. Promoter

2.1 The Promoter of the Event is Future Super Services Pty Ltd ABN 88 652 577 930, the Promoter of Future Super, a division of Smart Future Trust; AFS Representative No. 001312077 which is a Corporate Authorised Representative of Future Group Financial Services Pty Ltd ABN 90 167 800 580; AFSL 482684 (FGFS).

3. Event Details

3.1 The Event is *Future Council film screening* at Climate Action Week Sydney, located at Palace Cinema, 28 Broadway, Chippendale NSW 2008 on Thursday, 12 March 2026 at 6pm.

4. Eligibility

4.1 Registration is open to Australian residents aged 18 years and over. Attendees under 18 are permitted to register and attend provided they are accompanied by a parent or legal guardian for the duration of the event.

4.2 Employees of the Promoter and associated entities are not eligible to attend unless otherwise advised by the Promoter.

4.3 No purchase or payment of any kind is necessary to register for or attend the Event.

5. How to Register

5.1 Tickets must be registered for via the Promoter’s nominated booking platform *Luma* <https://luma.com/cawsyd26> during registration period from 6 Feb 2026 until 12 March 2026, while tickets remain available.

5.2 There is no limit to registration per attendee.

5.3 Tickets are strictly limited to a total of 80 tickets.

5.4 Once all tickets have been allocated, registrations will close automatically and no further tickets will be available.

5.5 The booking platform will not provide notifications when tickets are nearly allocated or fully allocated.

5.6 The Promoter takes no responsibility for registrations that are lost, delayed, incomplete, corrupted or otherwise invalid.

6. Tickets and Attendance

6.1 Tickets are free, non-transferrable and must not be sold, exchanged or

redeemed for cash.

6.2 Attendees must arrive on time. Late arrival may result in refusal of entry at the discretion of the venue.

6.4 The venue reserves the right to refuse entry or remove any attendee whose behaviour is unsafe, disruptive or inappropriate.

8.2 To the extent permitted by law, the Promoter accepts no responsibility for any loss, damage, injury or death suffered in connection with the Event, including travel to and from the venue.
