



# Feminist Forum for and beyond the Fourth International Conference on Financing for Development (FfD4)

Ushering an economic system based on care, justice and equality

27-28 June 2025 Hotel Giralda Center Seville, Spain

With preparatory webinars on 4, 11, 19 June 2025

#### Context

The Fourth International Conference on Financing for Development (FfD4) takes place at a time when intersecting global crises — economic, ecological, and social — are exacerbating inequalities, particularly for women in all their diversity and structurally excluded communities in the Global South. While governments and institutions revisit the international financial architecture, dominant responses continue failing to address the root causes of structural, social, racial, environmental and economic injustice. The upcoming 4th Conference presents a key moment to drive socio-economic change by simply prioritising all women and girls. It offers a once-in-a-decade opportunity for Member States to deliver systematic reforms, placing all women and girls at the heart of the financing agenda. However, Member States need collaborative efforts to achieve this. Enhancing the scope of the FfD4 process, therefore, necessitates strengthening a genuine multilateralism based on equality between countries and duty bearers' accountability to peoples. This requires bolstering the role and leadership of civil society and the women's movement, in shaping a feminist agenda that will lead to a robust outcome at FfD4. Moreover, the Conference presents a unique opportunity to build multi stakeholder partnerships amongst Governments, CSOs, Youth, International Organisations, the private sector and philanthropies to prioritise gender financing and mainstreaming women's human rights and gender equality in implementing the FfD4 outcome document.

Feminist movements have long exposed the colonial, patriarchal, racist and neoliberal foundations of the current economic order. We call for a just and transformative economic system rooted in care, redistribution, with a gender perspective, reparations, and human rights—one that centers the leadership and lived realities of women and gender-diverse people and brings together intergenerational collaborations across regions.

The Feminist Forum, convened just before the CSO Forum and official FfD4 proceedings, serves as a vibrant political commons where feminist advocates, activists, researchers, and organisers from every region converge to refine collective positions, forge unified strategies, and assert a powerful feminist voice within, and beyond, the Financing for Development process.



Women's Major Group Creating a Just & Sustainable Future

Designed to cultivate solidarity and strengthen feminist engagement, the gathering will weave together regional and thematic dialogues, apply a feminist lens to macroeconomic challenges, and debate transformative alternatives, giving us time to reflect, connect, and coordinate with collective unity, and formidable power for and beyond FfD4. It will bring together the voices of diverse women, including women political leaders, women in civil society, rural, women of African descent and indigenous women and those from structurally marginalized communities, and to connect these voices with key actors in the FfD4 process.

### **Objectives**

- To assess the progress in integration of feminist perspectives in financing for development since FfD3 and share common demands and build synergies around advocacy positions, including to amplify Global South and unified feminist perspectives on financing for development for and beyond FfD4.
- 2. To build intergenerational, intersectional and cross-regional feminist solidarity, shared analysis and capacity for feminist macroeconomic advocacy.

There will be three (3) preparatory webinars that will be organised before FfD4 for the Feminist Forum.
