Insurance Coverage

Zeekr will provide basic insurance coverage for the driver during the lease period. Additional insurance desired must be obtained and paid at the winner's own expense and must identify Zeekr as an interested party in any insurance policy.

Safety Compliance

The vehicle must be operated in accordance with all applicable traffic laws and safety regulations. The winner is responsible for the proper use of the vehicle and indemnifies Zeekr in relation to any loss, damage or injury that results from the use of the vehicle.

Vehicle Use Restrictions

The vehicle may not be used for commercial purposes (including ride and food delivery services), racing, or any illegal activities.

Additional Drivers

This agreement grants the winner a six-month exclusive lease of the vehicle, and operation of the vehicle is strictly limited to the lessee. Any unauthorised use will incur costs and liability solely borne by the winner. Any unauthorised or improper use, as determined by Zeekr in its absolute discretion, will entitle Zeekr to revoke the lease and reclaim the vehicle immediately.

Maintenance Responsibility

The winner is responsible for regular maintenance and any damages incurred during the lease period. The winner is required to return the vehicle in its original condition, as received at the start of the loan period. It should be clean and free of excessive dirt or debris. No significant alterations, modifications, or damages should occur during the loan term. Any damage, including dents, broken parts or significant cosmetic changes must be repaired before return. Prior to repairs, the winner must obtain approval from Zeekr in relation to the nature of the repairs and the repairer. The winner is responsible for any costs associated with repairing these damages.

Accident Liability

The winner is liable for any accidents or damages caused while operating the vehicle. If an accident or incident occurs, the winner must immediately notify Zeekr. The winner is required to file an insurance claim promptly and provide Zeekr with documentation related to the claim process.

If the vehicle is declared a statutory write-off, the winner will be responsible for covering the financial loss to Zeekr. This may include:

- The full market value of the vehicle at the time of the write-off, as determined by Zeekr, plus
- Any applicable deductibles or fees as specified in the loan agreement.

Inspection Requirement

The vehicle will be subject to inspections by Zeekr at the end of the lease period to assess the condition. The winner must be present during this inspection.

Legal Compliance

Tax and Other Liability
