## **ABOUT POSITIVE MONEY**

Positive Money is a fast-growing organisation that combines the activities of a think-tank, pressure group, and international movement. Our mission is to restore democratic control and transparency over the creation of money. Current monetary policy and the money system cause a wide range of economic, social and environmental problems; most notably house price bubbles, high levels of debt, and rising inequality. Our vision is a fair, democratic, and sustainable money system.

## **ABOUT THE ROLE**

Since 2010 Positive Money has been raising awareness about how the money system works and the detrimental impact is has on society - alongside campaigning for fundamental reform. Building a grassroots movement has always been a crucial part of our work.

We have an active network of over 30 local groups and activists across the UK - and sister organisations around the world. The Lead Organiser will work with the Positive Money team to implement the supporter strategy; to grow, diversify and strengthen Positive Money's supporter base, design opportunities for activism online and offline, integrate fundraising into the Positive Money network and raise the profile of the supporter network. The Lead Organiser will also support building our international movement for monetary reform.

## **ABOUT YOU**

You'll be an energetic organiser who is passionate about building a community around a campaign. You will be skilled at facilitating workshops and designing participatory events and you'll enjoy figuring out how to engage new audiences in economic issues. You will be naturally gifted at building relationships with a large number of people. Positive Money is a small team which works closely together, so you will also be someone who enjoys getting involved in different aspects of the organisation and juggling multiple projects.

- Initiate, plan, organise and manage national events
- Manage supporter donations, integrating fundraising into the supporter network
- Line-manage the Social Media Manager
- Equip local groups and individuals to campaign, fundraise and raise awareness of Positive Money at a local level
- Provide information to Positive Money staff and board about the activities of supporters and similar groups, and related online discussions and groups
- Plan, run and evaluate online campaigns including petitions and advocacy campaigns
- Write fortnightly newsletters and funding appeals
- Support the development of the international movement for monetary reform
- Contribute to organisation-wide decisions around deadlines, schedules, communications and prioritisation of tasks
- Identify needs within the Positive Money supporter network and develop training opportunities to respond to them
- Continue to develop online and offline resources to build capacity within the supporter network
- Contribute creatively to a dynamic and changing programme of work
- The role involves communicating with sensitivity and diplomacy responding to, and taking account of the diverse opinions, interests, needs and requests of others

**Contract:** The role is for an initial fixed term of 1 year with a 6-month probationary period. After a year if the contract is extended, a permanent contract will be offered.

**Location:** The role is based at Positive Money's office in central London at 212 Davina House, 137-149 Goswell Road, London with occasional work away from home

**Hours:** 35 hours per week with some flexibility; the post holder would be expected to work the occasional evening or weekend, with time off given in lieu. 4 – 8 weekends a year may be affected. We are committed to supporting flexible working and this job is available on a part-time or full-time basis.

Holiday: 25 days per year in addition to statutory holidays.
