In the EU office, our expertise lies within monetary policy from which we are building various policy interventions for a fairer, more democratic and sustainable economic system in the EU. We produce ground-breaking research and policy proposals, advocate for them with EU policymakers, and we engage in the public debate through regular media appearances and social media interventions.

Our current research areas cover the development of a green monetary policy to support a just and sustainable transition (including supporting energy efficient home renovations and the deployment of renewable energy); the role of the European Central Bank, the European Investment Bank and national central banks in the EU in such transition; the coordination between monetary and fiscal policy to maintain price stability and increase



green investments; the promotion of a universally accessible and safe digital euro for all citizens; the effects of monetary policy on income and wealth inequalities; the systemic risks of real estate holdings in the financial sectors, etc.

Fee contracts are elaborated on a case by case basis, either with a total fee for a specific deliverable (like producing a research report), or with a daily rate for other projects. Travel costs and other expenses may be discussed, depending on the needs of the organisation for the concerned project.
