

Verve Super ‘Melbourne Writers Festival’ Opening Night Giveaway – Terms and Conditions

1. Overview

- 1.1. Information on how to enter the Verve Super ‘Melbourne Writers Festival’ Opening Night Giveaway (“Giveaway”) forms part of these terms and conditions of entry. Participation in this Giveaway is deemed acceptance of these terms and conditions.
- 1.2. This promotion is a game of chance. It is free to enter, and each eligible entry has an equal chance of winning.
- 1.3. This promotion is in no way sponsored, endorsed, administered by, or associated with Instagram or Meta.
- 1.4. The Promoter of the Giveaway is Verve Superannuation Pty Ltd (ABN 65 628 675 169, AFS Representative No. 001268903), which is a Corporate Authorised Representative of Future Group Financial Services Pty Ltd (ABN 90 167 800 580; AFSL 482684) (the “Promoter”).
- 1.5. The Promoter is the promoter of Verve Super, a product of the Smart Future Trust ABN 68 964 712 340 (Verve Super).
- 1.6. The prize pool is provided by Melbourne Writers Festival ABN 29 367 097 058 (“Melbourne Writers Festival”) and is not funded by Verve Super member funds.
- 1.7. The Promoter is a partner of Melbourne Writers Festival. Melbourne Writers Festival is responsible for the delivery of the event and is not the promoter of this Giveaway.

2. Promotional Period

- 2.1. The Promotional Period commences at 4:00pm AEST on Monday 4 May 2026 and concludes at 4:00pm AEST on Tuesday 5 May 2026.

3. Entry Eligibility

- 3.1. Entrants must be a follower of the Verve Super Instagram account ([instagram.com/verve.super](https://www.instagram.com/verve.super)) and Melbourne Writers Festival ([Instagram.com/melbwritersfest](https://www.instagram.com/melbwritersfest))

- 3.2. Entrants must be Australian residents, aged 18 years or older.
- 3.3. Employees of the Promoter and associated entities are excluded from participating in the Giveaway, as are their immediate families.
- 3.4. No purchase or payment of any kind is necessary to enter or win.

4. How to Enter

- 4.1. To enter the Giveaway, eligible participants must post a comment tagging a friend's account on the official giveaway Instagram post shared by Verve Super.
- 4.2. Multiple entries per person are permitted.
- 4.3. The Promoter takes no responsibility for any entries which are lost, delayed, illegible, corrupted, damaged, incomplete or otherwise invalid.

5. Prize

- 5.1. The total Giveaway prize pool consists of two (2) prizes.
- 5.2. Each prize consists of one (1) double pass (two tickets) to the Melbourne Writers Festival Opening Night event on 7 May 2026.
- 5.3. Each prize is valued at \$70AUD. The total prize pool is valued at \$140AUD.
- 5.4. The prize will be delivered electronically to the winners.
- 5.5. The Promoter accepts no responsibility if a winner is unable to attend the event or use the prize for any reason.

6. Winner Selection

- 6.1. Two (2) winners will be drawn at random via an online generator at 4:00pm AEST on Tuesday 5 May 2026 by the Promoter.
- 6.2. Winners will be notified via Instagram Direct Message to the account used for entry within two (2) hours of the draw.
- 6.3. Winners will initially be contacted via Instagram Direct Message using the account associated with their entry. Winners may be required to provide additional personal information, including their full name and email address, for the purpose of prize fulfilment. This information will be handled in accordance with the Promoter's [Privacy Policy](#).
- 6.4. If a prize is not accepted via Direct Message reply within 24 hours of notification, it will be redrawn once only. A redraw will be conducted at 4:00pm AEST on

Wednesday, 6 May 2026 using an online random generator at the Promoter's premises, or remotely, in the same manner as the original draw. The redraw winner will be notified via Instagram Direct Message within two (2) hours of the redraw.

6.5. All reasonable steps to notify winners will be taken by the Promoter. The Promoter's decision is final and no correspondence will be entered into.

7. Prize Delivery

7.1. The prize will be delivered as e-tickets to the winners' nominated email address.

7.2. The Promoter is not liable for any issues with the recipient's Instagram Direct Message delivery.

7.3. The prize must be taken as offered, is not exchangeable or transferable and cannot be redeemed for cash. No responsibility is accepted for any variation in the value of the prize.

7.4. Any incidental costs relating to the prize are the responsibility of the winner, including travel to and from the event.

7.5. No compensation will be payable if a winner is unable to use any element of the prize for any reason, including but not limited to event cancellation, refusal of entry, or personal circumstances. Any unused portion of the prize will be forfeited.

8.1. The Promoter accepts no liability for any changes to the event program. The event organiser may change or cancel the program at any time.
