This Privacy Notice outlines what and how we collect, use, store, dispose, and protect your personal data. By accessing our website and/or submitting your information directly to the Etaily, you agree and consent to the use, collection, processing, storage, and disposal of your personal data as outlined in this Notice. Etaily is committed to being transparent about how it collects and uses that data and to meeting its data protection obligations.

- 1. **Information Collection.** Through our website, we may collect the following information from you:

- 5. Third-Party Disclosure. Etaily may share your information with third-party service providers through the applications that the company uses in its everyday operations. We have pronounced contractual terms with each service provider to protect the confidentiality and security of our data.

You have the right to obtain a copy of, move, or transfer any personal information relating to you. You have the right to object or to withhold consent with regard to the collection and processing of personal information. You have the right to suspend, withdraw or order the blocking, removal or destruction of your personal information. You may claim compensation if you suffered damages due to inaccurate, incomplete, outdated, false, unlawfully obtained or unauthorized use of personal information, considering any violation of your rights and freedoms as data subject. You have the right to dispute and have corrected any inaccuracy or error in the personal information we process about you.

For Philippine Data Subjects, if you feel that your personal information has been misused, maliciously disclosed, or improperly disposed of, or that any of your data privacy rights have been violated, you have a right to file a complaint with the National Privacy Commission of the Philippines.
