

My Health Record: Digital learning modules



Established by the federal government in 2016, the Australian Digital Health Agency (Agency) is working towards connecting Australians to a healthier future through connected healthcare.

Personal health information

- You can store details of people you would like to be contacted in a medical emergency in your record. This could be family members, or close friends or carers
- You can also upload any advance care planning documents, so your wishes can be safely and securely accessed if they were ever needed in a medical emergency
- You also have the option to add a health personal health note to record health notes or a personal health summary to share with healthcare providers

Accessing your health records

My Health Record is a safe and secure place to keep diagnostic imaging reports, electronic prescriptions and more. Find out how you can access your health information by reading the information below.

Immunisation information

Immunisation information comes from the Australian Immunisation Register and certain clinical documents in your record. You can store and access information about vaccines you have had in My Health Record, such as the COVID-19 vaccine.

Pathology and diagnostic imaging reports

Pathology reports may include results from blood tests, urine tests and biopsies and can be added to your record. A diagnostic imaging report may include results from X-rays, CT scans, ultrasounds and other diagnostic imaging examinations.

Medical conditions, allergies and adverse reactions

You can use My Health Record to keep track of your medicines, add any allergies and adverse reactions. The Medical Conditions View brings together a consolidated list of medical conditions and procedures from a range of clinical documents available in My Health Record.

Shared health, event and discharge summaries

A shared health summary is a clinical record written by your primary healthcare provider such as your GP. Event summaries contain information about healthcare events or consultations you may have. Discharge summaries contain important clinical information about care you received in hospital.

Prescriptions and shared medicines list

A prescription record is uploaded by the healthcare provider who prescribed your medicines and a dispense record is uploaded by the pharmacist who dispensed your medicines. A Pharmacist Shared Medicines List (PSML) is a list of all medicines you may be taking, including prescribed, over the counter and complementary medicines.

The **my health** app is a secure and convenient way to access My Health Record on your mobile device.

my health app now includes new functionality that allows you to add, edit and remove personally entered medicines information and allergies, manage electronic prescriptions and your Active Script List and personal health summaries.

Through **my health** app you can:

- Access and view your medical history.
- Check test results.
- View vaccinations and immunisations.
- View hospital discharge summaries.
- View and manage electronic prescriptions including your Active Script List (ASL).
- Keep track of care planning documents, and more.
