IGRC2024 will be held in Canada, a country leading the way in innovation and cleantech.

Membership Qualification

The IGU has two main membership categories: Charter Members (CM) and Associate Members (AM). *A limited number of Associate Members can also be invited to become Premium Associate Members (PAM), which grants them similar rights to those of the CMs.

Charter Members

IGU Charter Membership is reserved for one entity per country, which is the national gas industry representative. Most commonly it is the national gas association or a national gas company. Some Charter members are also represented by Ministries or national Regulators.

FEES are determined by the size of the given country's gas market*, ranging between €6,000 and €18,000

*Total annual natural gas production and consumption as reported by the UN

Associate Members

Associate membership is available to all companies owning physical and/or commercial gas-related assets and/or those who can demonstrate a clear interest in advancing the global gas industry, such as services. The main criteria to meet is being sufficiently vested in the advancement of the gas industry, including natural, renewable, low and zero carbon gases, or other gas decarbonisation technologies.

Annual fee €6,000

Premium Associate Members

Associate members can be invited to apply to upgrade their membership to Premium Associate status. This category grants most of the rights that a Charter member is entitled to, and for that reason the number of Premium spots is limited.

Annual fee €18,000
