#### PRIVACY NOTICE

Welcome to our landing page! This Privacy Notice (the "Privacy Notice") governs the manner in which Summoner Studio LLC, and its related and affiliated entities, unless otherwise stated or otherwise governed by such entity's own privacy notice ("Company") collects, uses, maintains, and discloses information collected from users (each, a "User") of its products, services, and/or its https://www.summoner.studio/website, applications, and technology platform, and any derivative or affiliated websites on which this Privacy Notice is posted, linked, or referenced (collectively, the "Site"). The Site is owned and operated by Company. Please note that this Privacy Notice covers Company's practices regarding information collected from/through its Site. Please read this Privacy Notice carefully to understand how we handle your information. By using the Site, you agree to the terms of this Privacy Notice. You shouldn't use the Site if you don't agree with this Privacy Notice or any other agreement that governs your use of the Site.

#### **Information We Collect And Receive**

The categories of information that are collected will depend upon the nature of your interaction(s) with us. Below are examples to help you better understand the data we may collect.

**Information you provide to us.** We may collect a variety of information that you provide directly to us in connection with your use of the Site and/or our services. While this Site is currently intended to be a static landing page without dynamic interactive features (except for certain links to extern sites), the specific types of information we collect may depend upon how you use the Site or our services and the information you choose to provide. #### **How We Use Information**

We may use personally identifiable information collected through the Site for the following reasons:

- for the specific purposes for which the information was collected;
- to fulfill a contractual obligation;
- to communicate to Users, including regarding products and services;
- to maintain and improve its products, services, and sites;
- to provide support;
- to inform Users of offerings that may be of interest;
- to process payments;
- for business planning, marketing, advertising and sales purposes;

- to comply with applicable law.

#### **Information Sharing**

We may share information that we collect about you in the following ways:

With our affiliates, service providers and third-party vendors. We may share information with companies affiliated with us. We contract with select third party vendors to provide services on our behalf, for example, services such as email, hosting, cloud storage, maintenance, backup and analysis, communications software, marketing, business strategy, banking, payment processing, professional services, background checks, etc. We also may share non-personal information (such as aggregate user statistics, de-identified information, demographic information, etc.) with third parties such as advertisers, content providers, and analytics providers.

To the extent required by law or to protect the company or others. We may disclose personally identifiable information at the request of law enforcement or governmental agencies or in response to subpoenas, court orders, or other legal process, to establish, protect, or exercise our legal or other rights or to defend against a legal claim or as otherwise required or allowed by law. We may disclose personally identifiable information in order to protect the rights, property, or safety of a User or any other person. We may also disclose personally identifiable information to investigate or prevent a violation by User of any contractual or other relationship with us or the perpetration of any illegal or harmful activity.

In connection with any business acquisition, sale, or merger, or in connection with investor relations. We may disclose or transfer personally identifiable information collected from Users in connection with or in contemplation of a sale of its assets or business or a merger, consolidation, or other reorganization of its business. We may also disclose aggregate, anonymous data based on information collected from Users to investors and potential partners.

Users may always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain Site-related activities.

# **Cookies and Other Tracking Technologies/Analytics**

These needs can vary based upon the data type and the context of the services, and thus the retention will vary as well.

#### **Security of Information**

We disclose potentially personally-identifying and personally-identifying information based upon user consent only to employees, contractors, and affiliated organizations that (i) need to know that information in order to process transactions on our behalf or comply with other legal or contractual obligations, and (ii) that have agreed not to disclose it to others. We take measures reasonably necessary to protect against the unauthorized access, use, alteration, or destruction of potentially personally-identifying and personally-identifying information.

Information about each User that is maintained on our systems is protected using industry standard security measures. We follow generally accepted standards to

protect the personal information submitted to us, both during transmission and once it is received.
