

5. Field Selection

To be eligible for selection horses must be nominated and sustained as prescribed herein to Level D or E or F. The fields for the heats and Final to be selected by:-

- The Handicapper of Harness Racing New Zealand
- A representative of the N.Z. Sires' Stakes Board
- A representative from host club involved

6. Race Programme and Details

Because of the ongoing changes within Harness Racing details of the race conditions, i.e. stakes, field selection, number of starters etc will be announced at the appropriate time for that particular racing season.

7. It is the responsibility of the person who is entitled to enter the horse in any race of this series to ensure that the horse has:
- i) Been nominated in accordance with the Board's requirements: and
 - ii) Required payments as prescribed in the series condition have been made at the time specified in the series conditions.

The Board shall have no obligation to ensure that a horse's nomination and sustaining payments have been made to the required level as prescribed in these conditions to ensure eligibility.

If the Board so requires, proof of nomination and sustaining may be required to be presented when a horse is entered in any race and/or on the day of the race.

The Board will not be liable for any costs associated with an incorrectly nominated and/or non-sustained horse no matter when the lack of nomination or non-sustaining has been identified.

8. Subject to the consent of the Chief Executive of Harness Racing New Zealand the conditions of this series may be amended as deemed necessary.

The rules, standing orders, regulations, and/or by-laws adopted by the N.Z. Sires Stakes Board and approved by the Society from time to time shall where applicable apply and be binding on all organizations, owners and all other persons entering any horse for any N.Z. Sires Stakes Series advertised by the Board whether such organization, owners and/or persons as the case may be, be resident in New Zealand or otherwise.

All prepayment monies will be allocated by the N.Z. Sires Stakes Board, at its discretion, to the Series and its associated costs and/or to the accumulated funds of the Society and/or for any new races developed within the series.

In the event of a race/race meeting being abandoned where any race within this series is scheduled to be held the Board may consider whether another race could be held at another suitable time and venue but this may not always be possible.

This series is administered by the N.Z. Sires Stakes Board Inc. The series and all races within this series are run under the Rules and Regulations of Harness Racing New Zealand.

SPECIAL NOTE APPLICABLE TO THESE CONDITIONS:

As the primary objective of increasing opportunities for foal owners to qualify for the major races of this series the Board is constantly examining a number of options designed to assist all nominators. As stated above, this also includes the right to include opportunities for four-year-old and older horses as a further development of the series. It is envisaged that to achieve that aim the foregoing conditions may be subject to change. The Board reserves the absolute right to make any amendment it thinks fit subject to consultation with and approval by Harness Racing New Zealand. Any such changes will be officially advertised.

General Conditions

The Series is open to any filly that is a foal in the 2024/25 season to nominate.

1. A series of races for 3-year-old **pacing** fillies to be raced within the 2028 calendar year. Details of races and venues to be announce at the appropriate time for that racing year. The Board reserves the right to include opportunities development of new races – for example – four-year-old and older mare's races – with conditions and payments for those races to be determined within their relevant racing year.

2. Nomination and Sustaining Payments

- i) All entries for foal nomination and sustaining payments must be received by the Secretary of the N.Z. Sires Stakes Board at its registered office by the closing date. Any such nomination forwarded by post and postmarked no later than the closing date will be accepted. Where a closing date falls on a Saturday, Sunday or public holiday the following working date will be deemed the closing date, Providing the horse name and series is given at the time; the Board will accept payments paid directly into the nominated bank account and must be received into that account by the closing date as prescribed within these conditions. Where any nomination is sent by post or direct credit but is not received until after the closing time the Board may admit the same subject to its satisfaction that it should in the ordinary course of post or payment process have been received in time. Telephone entries will be accepted providing MasterCard/Visa details are also given at the time.
- ii) Late Premium Provision is included as prescribed herein.

Any sustaining payments due but not received as above will be deemed to constitute a withdrawal of the horse concerned making it no longer eligible for the series.

Where payments are inclusive of GST these are at the rate of 15% and are subject to change.

Nevele R Fillies programme extension to aged and other race options

Unless categorically stated otherwise in the Board's announced conditions, to be eligible for any Aged or Special races linked to this series a horse, unless it can comply within another race series payment level as prescribed in those particular race conditions, must have been paid both the Foal Payment (Level A) and the Yearling Sustaining Payment (Level B) or Fully Paid Up. Where a late entry has been paid for the Nevele R 3 Year Old Fillies Series those horses will also be eligible. This is subject to horses meeting the race conditions for each particular race.

All entries for foal nomination must be received as above – **closing date 1st July 2025.**

Payment E – One Up Payment

Nominator may, at their option, make a "One-Up" payment which will result in the filly concerned being regarded as "Fully Paid Up". No further sustaining payments are then required – closing date **1st July 2025** (Late extension not applicable to Level E)

Overseas Sired Foals:

Any filly that does not have a New Zealand identification will in addition to the foal nomination fee pay premium fee of NZ \$200-00 (GST inclusive) (Total \$380)

YEARLING SUSTAINING



Payment Level B – Yearling

A further yearling sustaining payment will be due by the closing date to remain eligible – **closing date**

1st July 2026.

Level B Fee **\$295.00** (GST inclusive)

Late Premium Provision – As above ii

Closing 15th July 2026 5% premium **\$309.75**

Closing 1st August 2026 50% premium **\$442.50**

Payment Level F – Yearling

Providing the filly has been nominated as a foal as per payment A it can be "Fully Paid Up" and no further sustaining payments are required. To validate for this option payment is due – **closing date 1st July 2026** (Late extension not applicable to Level F)

Level F fee **\$600.00** (GST inclusive)

(Payment D not then required)

Failure to make either one of these payments by the due date will eliminate the horse concerned making it no longer eligible for the series.

THREE-YEAR-OLD SUSTAINING



Payment Level D – 3-Year-Old

A final sustaining paying will be due by the closing date to validate entries of the series – **closing date 1st July 2027**

Level D Fee **\$400.00** (GST inclusive)

Late Provision as ii

Closing 15th July 2027 5% premium **\$420.00**

Closing 1st August 2027 200% premium **\$1,200.00**

Failure to make this payment by the due date will eliminate the horse concerned making it no longer eligible for the series. While the Board endeavour's to forward reminder remittance advices (where HRNZ holds an email address these may be emailed otherwise normal post) it will not be held responsible for any not reaching the correct owner or destination. It is the responsibility of the owner to ensure that a horse is nominated and sustained as prescribed in these conditions. No entry will be accepted without payment and the failure to make all payments by the advertised date will mean the elimination of the horse from the part of the series for which the payment was due.

3. Three-Year-Old Late Entry – NZ Microchipped Fillies Only

Any filly that does not have a New Zealand approved identification (NZ microchipping) will be ineligible to enter the race series by payment of a late entry.

Where a filly that has a New Zealand identification and has not been nominated and sustained to the required level for any age group series will be eligible by payment of a late entry.

- a) The late entry may be made – either –
15% plus GST of the estimated stake that is advertised in the Programme Conditions for the three year old Fillies Final for that race season.

Or –

If the foal nomination fee Level A has been made the late fee will be 10% plus GST of the estimated stake that is advertised in the club's programme conditions for the three year old Fillies Final for that race season.

For other "special" races where eligibility is connected to Series No 50 the late entry fee will be announced within the programme conditions of each specific race.

The late payment is to be paid to the N.Z. Sires Stakes Board by the closing of nominations for the said heat that the filly intends to first contest. Where the horse is not selected for that event or was on the emergency list and became a compulsory scratching and in all cases and all respects has complied with the Rules of NZ Harness Racing, the late entry fee may be refunded. If for any other reason a late entry has been paid and the horse is unable to start the nominator may apply to the Board for a refund and the Board in its sole discretion shall decide whether or not a refund is affected. A veterinary certificate may be required.

4. **Nominators Stakes Award** – An amount of 4% of the total stake of the Final shall be divided 2.5%; 1%; 0.50% and paid to the person(s) who was deemed the foal nominator of the first three placed fillies in the Final. (excludes late entries) This money to be allocated from the total stake of the Final. If any of the first three to finish in the Final were nominated by a Late Entry, the Nominators Stakes Award shall be paid respectively to the nominator of the next eligible placed filly. Where no foal nominator has been specified it will be deemed the person/s who is the registered owners with HRNZ at the time the payment was received.
