Terms and Conditions of Use

1. DEFINITIONS

- "Company" means Geely Auto South Africa (Pty) Ltd, a company duly incorporated under the company laws of the Republic
 of South Africa, with registration number 2025/255980/07, and principal place of business at 42 Saturn Crescent, Linbro
 Business, Linbro Park, Johannesburg.
- "POPI" means the Protection of Personal Information Act 4 of 2013.
- "Personal Information" means information relating to an identifiable, living, natural person and, where applicable, an identifiable, existing juristic person.
- "Processing" means any operation or activity concerning personal information, including collection, storage, modification, and dissemination.
- "Online Services" refers to the Company's website(s), digital platforms, customer portals, and all electronic services provided by the Company.
- "ECTA" means the Electronic Communications and Transactions Act 25 of 2002.
- "User", "you", "your" means any person who accesses or uses the Company's website and online services.
- "Cookies" are small text files placed on your device to identify repeat users, track usage behavior, and store user preferences.
