

## Privacy Statement of Geely Auto South Africa (Pty) Ltd

This Privacy Statement sets out how your personal information will be used by Geely Auto South Africa (Pty) Ltd ("Geely Auto SA") and applies to any information, including personal and special personal information, that you give to Geely Auto SA, or which Geely Auto SA may collect from third parties.

It is important that you read this Statement carefully before submitting any personal information to Geely Auto SA.

By submitting any personal information to Geely Auto SA, you provide consent to the processing of your personal information as set out in this Statement.

The provisions of this Statement are subject to mandatory and unalterable provisions of Applicable Laws.

Please do not submit any personal information to Geely Auto SA if you do not agree to any of the provisions of this Statement. If you do not consent to the provisions of this Statement, or parts of the Statement, Geely Auto SA may not be able to provide its products and service offerings to you.

### Important Terms:

"Applicable Laws" means local, foreign and international laws, regulations, treaties and codes, including but not limited to the Protection of Personal Information Act 4 of 2013, the Consumer Protection Act 68 of 2008, the National Credit Act 34 of 2005, and the Financial Intelligence Centre Act 38 of 2001.

"Geely Affiliate" means, in relation to Geely Auto SA, any company or entity which directly or indirectly controls, is controlled by, or is under common control with Geely Auto SA.

"Geely Auto SA" or "Geely" or "we" or "our" means Geely Auto South Africa (Pty) Ltd (Registration Number: 2025/255980/07), including its divisions, subsidiaries and affiliates. Further details of affiliated companies may be available on our website or in our Legal Notice.

"Geely Dealer" or "Approved Dealer" means a non-exclusive authorised dealer appointed by Geely Auto SA who operates in its own name and for its own account, and who offers Geely vehicles and services in accordance with a dealership agreement with Geely Auto SA.

"Client" or "you" or "your" means any prospective, new or existing client of Geely Auto SA, any Geely Affiliate, Supplier or Dealer.

"Personal information" means information relating to an identifiable, living natural person and, where applicable, an identifiable existing juristic person, as defined in the Protection of Personal Information Act and other Applicable Laws.

### Can this Privacy Statement be amended?

We may amend this Statement from time to time for any of the following reasons:

- to reflect changes in our products, services, or operations;
- to accommodate new legal or regulatory requirements;
- to reflect changes in industry practices or market conditions;
- to enhance clarity or improve terms for your benefit;
- to rectify any error or omission identified in the Statement;
- or for any other reason Geely Auto SA may reasonably determine necessary.

Any such amendment will become effective upon publication on our website. It is your responsibility to check our website regularly for any updates.

### Are Geely Dealers or Service Centres included in this Privacy Statement?

If you purchase a vehicle or service from an approved Geely Dealer or Service Centre, or otherwise provide your personal information to them, a separate relationship will exist between you and that entity. Approved Dealers and Service Centres are separate legal entities and not agents of Geely Auto SA. You are encouraged to contact the relevant Dealer or Service Centre directly regarding their use of your personal information.

### How does Geely Auto SA handle website privacy and security?

We take reasonable precautions to protect the security and integrity of our website. However, no data transmission over the Internet can be guaranteed as fully secure. Accordingly, Geely Auto SA cannot be held liable for any loss, interception, or unauthorised access to information transmitted electronically beyond our control.
