

RACE REGULATION

The race called INFERNO is a running event with obstacles. The event is structured in one or more running tests of between 2 and 14 km in length with the presence of natural and artificial obstacles, on mixed asphalt and dirt roads, open to all, men and women over the age of 18 (13 or 16 for some distances), in possession of regular medical certification (see specifications below).

PATH AND OBSTACLES

The total length of the route is between 2 and 14 km. The route will include obstacles, natural and artificial. The map of the official route will be published on the website www.infernorun.it. In addition to dexterity, ability in climbing, jumping, swimming, running speed will be essential to complete the competition. The route can also include the crossing of ditches, woods, rough terrain, with woods, trunks or roots, wires or ropes, rubble or surface rocks. The risk of stumbling and falling is constant. The Organization wishes to highlight that during the overcoming of obstacles, as well as on the entire race course, accidents and / or accidents may occur. Furthermore the dangers can be caused by the fall of participants that involve other competitors. We therefore recommend adapting your pace to the terrain, visibility conditions, the type of obstacle to be addressed and the overcrowding of the stretch of the route.

Due to the number of participants, the visibility of the competition terrain is not always ensured. In this case, it is forbidden for participants (mudders) to continue at maximum speed. It is mandatory to reduce the speed to adapt to the terrain and visibility conditions. Approaching every obstacle, the participant must pay the utmost attention to the information signs present and to the indications of the personnel managing the obstacle. More detailed information on the route and the relative obstacles will be available on the official website of the event.

RACE, RULES AND DISQUALIFICATIONS

Obstacles are present on the course to test the participants. The race is open to competitive and non-competitive participation.

PRO Race

Participants in a competitive manner will start first in one or more bolges (batteries) reserved for them, they will have a particular race number and will be equipped with one or more chips for detecting the running time. The race direction reserves the right to divide or move the participants (for example men and women or the composition of the batteries) if it considers the organizational necessity.

The management reserves the right to vary the times and the pit (battery) selected during registration if this is functional to the running of the race.

For the PRO participants in the race, the obstacles must be overcome and not circumvented. If an obstacle is not passed, it is not correctly passed or is bypassed the test cannot be considered passed.



The competitor who runs in a competitive way will have to overcome obstacles without receiving outside help.

Each competitive athlete is given three bracelets (also called bands). They must all be worn and will be necessary to enter the starting cage, they are personal, they show the bib number, they cannot be sold.

Every obstacle can be attempted an infinite number of times.

For each failed obstacle, a band is cut and this is kept by the judge as evidence for a possible final check.

The final ranking will be based on the time of arrival and the number of bands stored.

The priority is given based on the time of arrival to those who kept all three bands, then to those who kept two, then to those who kept at least one.

Once the route has been completed and in any case before the start of the race the race director will communicate the time limit beyond which he is not counted in the standings.

The race direction can also make use of a Brooming Service (an athlete of the organization that leaves last) that reaches the athletes and eliminates the athletes from the competition. This system can be replaced by time gates that indicate a time limit within which to arrive at a specific point on the route.

Competitive athletes are prohibited from disqualification from trying obstacles before the race.

It will be the responsibility and responsibility of each participant in a competitive way to verify that the finish judge correctly registers the number of bands with which the race ends.

!!! EACH ATHLETE WILL BE LIABLE FOR HIS OWN CONTROL DEVICES (BANDS AND CHIP TIME DEVICES), THE LACK OF ONE OR MORE THAN THOSE WILL NOT BE IN ANY CONTEXT WAY !!!

IMMEDIATELY AFTER THE ARRIVAL LINE, EVERY COMPETITOR MUST RECORD THE NUMBER OF BRACELETS WITH WHICH IT HAS CONCLUDED THE RACE, TAKE OUT THE OWN SHOES THE CHIP AND DEPOSIT IT IN THE SPECIAL COLLECTION POINT!

Although not provided for in this regulation, reference is made to the [regulation of the Italian OCR Championship ed. 2018](#)

The path cannot be cut and **the athletes who will benefit from a path cut will be disqualified**. An intermediate time electronic platform will be used to have this detection in real time.

The bib number must always be visible. If an athlete does not have his own bib number, he can be stopped by the judge.



Each judge will have a marker to be able to write again the number on the body of the athlete the bib number.

Among the athletes there will also be incognito judges who can report to the judge of an obstacle or at the end of the race any incorrect behavior or assign penalties.

Athletes will not have to leave anything they have brought with them including gels, food or other items along the way.

Abandonment of waste along route may lead to disqualification.

PENALTY

Every obstacle can be attempted an infinite number of times.

Athletes who attempt an obstacle for the second time should not hinder athletes on the first attempt.

The left lane, where present, is reserved for athletes at the first attempt.

In the event of failure to pass on the first attempt, the competitor must try again by positioning himself on the lanes, if present on the right.

The fastest athletes will be able to ask for road and space to pass by shouting "road" or "permission" or something like that.

Competitive athletes achieved by uncompetitive athletes will have no priority in the row at the obstacles.

Athletes of non-competitive games will have no penalty in case of failure to overcome an obstacle.

Rules, valid for all competitive athletes without exception:

1. immediately use the lines of the first attempt and of the second if the latter are free
2. in the case of a second attempt, use only the second attempt lines
3. in the case of multiple attempts, use only the second attempt lines
if there is a queue, go back to the end of the line and wait for your turn
it is forbidden to touch the supports of the structure
4. unlimited number of attempts
5. in case of surrender to go to the judge, get the band cut

OPEN Race

All participants in the non-competitive race will be equipped with chronometric detection chips, but the race will not be competitive. Participants in the non-competitive event must assess the obstacle and their ability to overcome it before attempting to overcome the obstacle.

The organization adheres to the "[Carta Etica dello Sport - Regione Toscana](#)" that promotes fair behavior and mutual aid. The Organization staff will monitor the route and the obstacles, in order to verify that the race continues smoothly and in compliance with the rules. In the event of non-regulatory behavior, the staff can report the bib number to



the Organization and the competitor, although concluding the test, may be disqualified. The path and the obstacles are designed in such a way as to limit the waiting in front of each obstacle to the maximum. However, in case of waiting, the Organization expects each mudder to behave in a fair and polite manner. We remind you that INFERNO is an obstacle course and potentially dangerous and the safety of the participating mudders is the highest priority of the organization, for this reason there may be waiting times at obstacles longer than expected.

The organization reserves the right to modify the route or to close individual obstacles at any time. Each participant is obliged and encouraged to behave in a fair and sporting manner, for example by helping other mudders to overcome obstacles. The Mudders help each other and only loyal mudders are true Mudders!

REQUIREMENTS FOR PARTICIPATION

All those who, on the day of the race, have turned 16 yo, women men, of any nationality (or 13 yo for the 5km race) can participate in the event.

MEDICAL CERTIFICATE

Participation in the competitive race requires a medical sports certificate for competitive activity B1, valid at the date of the race or drawn up no later than 12 months before. For Italian athletes it is mandatory to present a copy of the valid medical certificate to the collection of the bib number or according to the electronic methods indicated on the race website. Accepted medical certificates are those that meet the B1 model.

Participation will not be allowed to those who present only a sports federation, RUNCARD or other sports promotion body card, not accompanied by a medical certificate. Foreign athletes will have to have the certificate made available by the organization on the website www.infernorun.it filled in, stamped and signed by a doctor

For the Open race, the basic requirement is the presentation of a medical certificate for non-competitive sporting activity at the time of collecting the bib number or at the time of registration.

The organization reserves the right not to accept a medical certificate that is illegible or unclear and consequently does not allow participation in the competition.

RELEASES

When registering, on www.infernorun.it, all those wishing to participate in INFERNO will subscribe to the knowledge and acceptance of this regulation and the related declarations, as per the following texts and available as an attachment to this regulation:

DECLARATION (PERSONAL STATEMENT)

"DECLARATION: I, the undersigned, with the signature at the bottom of this letter, aware of the penalties provided for false statements and false statements (Article 26 of Law 15/68 and Article 489 of the Italian Criminal Code) declare: that I have read and consequently know, accept and respect the "INFERNO" regulation; to be aware that participation in this type of sporting event is potentially a risk activity if you are not adequately prepared and in suitable physical conditions; trained and in good physical shape, aware that in order to



register you must be in possession of a medical certificate of good health (for non-competitive sports or recreational-motor activities) valid and have turned 18 on the date of the event; to register voluntarily and to assume all risks deriving from my participation in the event: falls, contacts with vehicles, with other participants, spectators or other, condition of time, including scorching heat, extreme cold and / or damp, traffic and road conditions, natural and artificial obstacles placed on the course, every type of risk well known and evaluated by me. Being aware of the above, considering the acceptance of my registration, I, on my behalf and in the interest of no one else, raise and free the ASD Italian Sport Lab, Andromeda Sport SSD arl the organization that organizes "INFERNO", CSEN, OPES, FIPM, OSF, EOSF, UISP, the local Municipal Administrations involved in the passage of the event, the sponsors and partners of the event, the respective representatives, successors, officers, directors, members, agents and employees of the aforementioned Companies, all technical partners, from all present and future claims or responsibilities of any kind, known or unknown, derived from my participation in the event. Once the registration for "INFERNO" 2018 is accepted, the participation fee is non-refundable, even in the event of cancellation. I grant my authorization to all the entities listed above to use photographs, tapes, videos, images within the website and anything related to my participation in the event for any legitimate use without remuneration".

PRIVACY DISCLAIMER

art.13 of Legislative Decree 196/2003 ("Code regarding the protection of personal data") we inform:

- 1) that the data contained in the registration form are required for registration, to prepare the list of participants, the preparation of the order of arrival, the historical archive, to carry out the services declared in the regulation and for sending of informative material of "INFERNO" and that the data contained in the present model are required for the registration to "INFERNO";*
- 2) that the consequences of not providing the aforementioned data or information consist in the non-admission to the event.*
- 3) With your consent, your personal data reported in the framework of personal data may be communicated to other companies and used to contact you and send you commercial and / or promotional information on products and services and carry out statistical analysis, studies and market research. The updated list of companies to which your data may be disclosed is available to the Data Controller. In this case these companies will be able to contact you as Owners of autonomous initiatives, for market research or to send you commercial information and / or promotional offers of products and services. Your data will be kept and processed in compliance with the security measures required by law, with or without the use of electronic means. Rights of the interested party (Article 7 of Legislative Decree 196/03). At any time, the interested party may consult, modify and cancel his / her data free of charge by writing to the person responsible for processing personal data at ASD Italian Sport Lab and o Andromeda Sport SSD arl. I consent to the communication of my data to allow me to receive scientific and commercial information, free samples, discount vouchers or be contacted for opinion polls.*



IMAGE RIGHT

By registering for the "INFERNO", the athlete expressly authorizes the ASD ITALIAN SPORT LAB and Andromeda Sport SSD arl to shoot the image of the undersigned in the course of his / her participation in "with television, film, photo or other means INFERNO "and to confirm this authorization with this declaration, recognizing ASD Italian Sport Lab and Andromeda Sport SSR arl the broadest right, but not the obligation, to record it, reproduce it, print it, publish it, project it and spread it, and in any case use it with every means currently known or to be invented in the future, without time limits or of any kind, all over the world and to sell them to third parties also for promotional and / or advertising purposes. The athlete also declares that he has nothing to claim from the ASD ITALIAN SPORT LAB and Andromeda Sport SSD arl and / or his assignees and / or assignees, and generally from anyone who uses and exploits his image, being every claim of the Athlete satisfied by the opportunity to take part in the sporting event.

REGISTRATION METHOD

The enrollment fees have been designed with the criterion of "first book, best price". Basically the first registrations benefit from a privileged treatment compared to those who register last. The minimum registration fees required are shown on the infernorun.it website.

The registration fee includes:

- Timing service with microchip
- official shirt (size subject to availability) HELL;
- stock deposit service;
- changing and showers service;
- refreshments or water points on the course;
- race pack;

The registration procedures will be communicated on the official website of the event www.infernorun.it, the requested data are necessary as well as the acceptance of privacy and regulation and the payment in the foreseen modalities of the enrollment fee. Entries can be made exclusively online on the site www.infernorun.it and the accepted payment methods are published on the site itself.

The Organization reserves the right to close or re-open registrations for the event at any time it deems appropriate and in any case notifying them on the website www.infernorun.it.

The registration will not be canceled or refunded for any reason.

The change of ownership will be regulated as follows:

- 15 euros for transition from OPEN to PRO category (subject to availability)
- 10 euros per change of ownership up to 20 days before the event
- 15 euros per change of ownership in the last 15 days before the event

No change or transfer in the last 5 days

To transfer the entry to another INFERNO race:



to request no later than 5 days before the event, 10 euros for transfer to another race (a coupon equal to the amount paid, less 10€, is sent to the same email used during registration)

SUSTAINABILITY

The Organization and its partners respect environmental sustainability in all aspects of their business. For this reason, all participants and people involved in the event are required to protect the environment. Compliance with legal regulations relating to the environmental sector is an essential condition for taking part in the event. This mainly concerns waste management, soil conservation, water conservation and pollution control. Specific containers for separate collection will be prepared and all participants are invited to take an active part in recycling. A shoe collection service will also be arranged.

BIB COLLECTION AND SWAG

Bib and swag can be picked up at the INFERNO Village on the day of the race or in the additional ways that will be communicated. The bibs can also be picked up by third parties, with a written proxy and a photocopy of a valid identification delegate document. The race number bib is strictly personal, cannot be tampered with and cannot be transferred to anyone.

TIMING AND TIME LIMIT

Participants in the race will be provided with one or more chips for the detection of their own race time, based on the time recorded an order of arrival will be drawn up. The measurement of times and the processing of arrival orders will be carried out using an electronic system and failure to return the transponder chip may result in a charge to the participant.

The time limit is set for each race and communicated at the time of departure. Beyond this time the Organization will not guarantee the complete safety of the race course and the timing will not be continued. Any mudder that fails to comply with this limitation will be recorded as "NOT Completed" in the results list. In any case, the race can be completed by all mudders that will cross the finish area.

BAG DROP, CHANGING ROOM AND SHOWERS

Changing rooms, bag drop storage and showers are available to participants near the arrival / departure area. The shower service may be subject to waiting times depending on the number of participants, in which case we recommend adequate and civil behavior during the wait.

The Organization assumes no responsibility for personal items unattended or forgotten in such environments or for theft or damage

DEPARTURE

The athletes participating in the competitive race will start first, in one or more batteries (bolge) depending on their total number. The assessment of the number of batteries (bolge) will be decided by the race organization based on the number of participants, obstacles and race safety. The organization also provides for the departure of the



non-competitive race in batteries (bolges) that can be booked to avoid excessive queues at the obstacles.

The organization reserves the right to modify the procedure and departure times to improve the fluidity of the race. In this case the changes will be communicated in due time.

RESPONSIBILITY OF THE ATHLETE

The athlete is required to keep informed about the rules, how to overcome the obstacles, the details of the event that will be communicated on the website of the event itself.

The member is responsible for the ownership and custody of his race number, acquiring the right to use all the services mentioned in this regulation and / or subsequently communicated.

a) Anyone who, without regular registration, participated without a bib, in addition to being held responsible for damage to persons or property, including himself, will incur sports sanctions for which federal bodies are responsible and may be subject to the penal sanctions provided for the crime of " theft "(Article 624 of the Italian Criminal Code).

b) Anyone who, without regular registration, participated with a counterfeit bib or otherwise not in compliance with the assignment, as well as being responsible as indicated above, will incur sports sanctions and, moreover, may be subject to the penal sanctions provided for the crime of "theft "(Article 624 of the Italian Criminal Code), or, alternatively, for the crime of fraud (Article 640 of the Italian Criminal Code). In cases a) and b) the participants may be subject to the penalties provided for the offense of "failure to comply with the provisions of the Authorities" (Article 650 of the Code). The aforementioned cases will be found only after verification of photographic and / or video documentation.

AWARDS AND CERTIFICATES OF PARTICIPATION

Prizes will be awarded to the first three men and the first three women and the first three teams in the competitive race. If the logistics and the times allow it, the first of each age category will also be awarded.

For the Open race there will be prizes at the discretion of the organization that will be communicated on the race website (for example illustrative and not exhaustive for the best costumes, the largest group, the mudder that comes from farthest, ...), also all the participants who will finish the course will have fame, glory and the satisfaction of having completed the race.

The award ceremony will take place approximately two hours after the competitive race closes at the finish area. The final results and the alphabetical order of arrival will be published after the end of the race on the official website. All mudders can download and print their participation certificate on the competition website.

MEDICAL SERVICE



The Organization will provide an adequate assistance service on the path and at the point of departure and arrival. Ambulances, first aid facilities and paramedical services, located in the focal points of the course, will provide the appropriate medical service to all participants. The doctors and paramedical staff are authorized to prohibit the continuation of the race for injured or too tired mudders, in order to guarantee their own safety.

FINAL WARNINGS

The event will be carried out in any weather condition, without prejudice to the organization's right to suspend the tender for issues related to the safety of the participants or public order.

The Organization reserves the right to cancel the event and to modify the present regulation at any time for reasons it deems appropriate for a better organization of the competition.

Any changes to services, places and times will be appropriately communicated to the registered mudders and will be reported on the website www.infernorun.it. Furthermore, the documentation containing the essential information to take part in the tender will be delivered by the organization together with the bib number.
