# RACE REGULATION INFERNO

The INFERNO race is a running event with obstacles. The event consists of one or more running events of between 2 and 14 km in length with natural and artificial obstacles, on mixed asphalt and dirt or snow-covered terrain, open to all men and women over 16 years of age (from 13 years for shorter distances), in possession of regular medical certification (see specifications below).

The map and the athletes' guide are published prior to each event and should be considered an integral part of these regulations.

Further limitations or restrictions due to regulations, DPCM decrees or other legal norms with respect to what is stated below will be communicated on the event website and on the relevant social channels.

## **ROUTE AND OBSTACLES**

The total length of the course may vary for each event and will be communicated on the event website. The route will include obstacles, both natural and artificial. The official route map will be published on the website [www.infernorun.it](http://www.infernorun.it). In addition to dexterity, climbing, jumping and swimming skills, running speed will be essential to complete the competition. The course may also include crossing ditches, forests, rough terrain, with wood, logs or roots, wires or ropes, rubble or surface rocks. The risk of stumbling and falling is constant. The organisers would like to point out that when overcoming obstacles, as well as on the entire race course, injuries and/or accidents can occur. In addition, dangers can be caused by participants falling over involving other competitors. We therefore recommend that you adapt your pace to the terrain, the visibility conditions, the type of obstacle to be tackled and the crowding on the stretch of track.

Due to the number of participants, visibility of the terrain is not always guaranteed. In this case, it is forbidden for participants to continue at full speed. It is compulsory to reduce speed in order to adapt to the terrain and visibility conditions. When approaching each obstacle, the participant must pay the utmost attention to the information signs present and to the indications of the staff managing the obstacle. More detailed information on the course and its obstacles can be found on the official event website.

## **RACE, RULES AND DISQUALIFICATIONS**

Obstacles are present on the course to test the participants. The race is open to both competitive and non-competitive participants.





## **Competitive race**

Competitive participants will start first in one or more bolges (batteries) reserved for them, will have a race number printed on each bracelet and will be equipped with one or more chips to record their race time. The race management reserves the right to divide or move the participants (e.g. men and women or the composition of the batteries) if it considers it necessary for organisational or health reasons.

The management reserves the right to change the times and the battery selected during registration if this is necessary for the running of the race.

Athletes who are serving a disqualification for doping or who are disqualified by the Italian OCR Federation are not allowed to take part in the competitive race.

For participants in the competitive race, obstacles must be overcome correctly and not circumvented, without receiving help from outside. Otherwise, the obstacle cannot be considered to have been overcome.

Each competitive athlete is given three bracelets (also called bands). They must all be worn and are necessary to enter the starting cage, they are personal, carry the bib number and cannot be given away.

**EACH ATHLETE WEARS 3 WRISTBANDS. ON THE SUSPENDED OBSTACLES ONLY ONE PASS ATTEMPT PER OBSTACLE IS ALLOWED. EACH OBSTACLE FAILURE RESULTS IN A BRACELET BEING CUT.**

Before the finish line the athletes are "filtered" according to the number of wristbands in their possession:

With 3 wristbands they can continue directly to the finish line for the time recording.

With 0 wristbands they can continue directly to the finish line for the time recording. They will be listed in the ranking without a finish position as DNF, but the finish time will be shown.

with 1-2 wristbands they must do the penalty loop (1 or 2 times) to make up the missing wristbands. After successful completion of the race the athlete can continue to the finish line for the time recording.

## **PENALTY LOOP**

Consists of a running, carrying or strength test or other.

It must be completed a number of times equal to the number of wristbands lost, up to a maximum of 2.

It is placed near the finish line

Those who fail the penalty loop test will have all their wristbands removed and after the finish line are considered DNF (did not finish).

In order to control the passage of the athletes on the Penalty Loop an electronic control platform can be set up on the course of the Penalty Loop, which will be kept as proof of passage in addition to the wristbands.

For each failed obstacle a band is cut, held by the judge as proof for a possible final check. Since people arrive at the finish line with zero wristbands (DNF, did not finish) or with





three, the final ranking is based on the finishing time and includes only those who have three wristbands on their wrist.

Once the course has been completed and in any case before the start of the race, the race director will announce the time limit beyond which you will not be counted in the ranking.

The race director may use a "Scopa" service (an athlete of the organisation who starts last) which "cleans" the course and closes the competitive race. This system may be replaced or supplemented by time gates indicating a time limit within which to arrive at a given point on the course or at the finish line.

Competitive athletes are forbidden, under penalty of disqualification, to try out the obstacles before the race. It will be the care and responsibility of each participant in a competitive manner to ensure that at the finish line the race judge correctly records the number of bracelets with which the race ends. Each athlete is responsible for his own control devices (bracelets and chips), the lack of one or more of these cannot be contested in any way. Immediately after the finish line each competitor must register the number of bracelets with which he finished the race.

For anything not provided for in these regulations, reference is made to the regulations of the Italian OCR Championship issued by Federazione Italiana OCR and Campionato Italiano OCR available on their respective websites.

The course may not be cut, athletes who benefit by reducing the course or avoiding obstacles will be disqualified. An electronic intermediate time platform may be used to provide this real-time detection and to check the actual passage. Incognito judges may also run among the athletes to report to the judge at an obstacle or at the end of the race any misbehaviour or award penalties.

Athletes must not leave anything they are carrying along the route, including gels, food or other items. Dropping litter may lead to disqualification.

## **PENALTY**

The fastest athletes may ask for a way and space to pass by shouting "way" or "permission" or similar.

- Rules valid for competitive athletes on the hurdles NOT IN SUSPENSION:
- use the first and second attempt lines immediately if they are free
- In case of a second attempt, use only the second attempt lines.
- in case of several attempts use only the second attempt lines
- in the event of a failed attempt, if there is a queue, move to the back of the queue and wait your turn
- Do not touch the structure's supports
- the number of attempts is unlimited (except for suspended obstacles)
- In case of abandonment, go to the judge and have your wristband cut off.





## GARMIN ONE



Within each competitive race of the INFERNO SERIES circuit, a special kilometre may be identified, hence the name GARMIN ONE. The start and end of this section of the course will also be clearly identified by two chip control carpets for recording the entry and exit times of each participant. The winners of the challenge, men and women, will be those who complete GARMIN ONE in the shortest possible time and overcoming every obstacle, i.e. not losing any bracelets.

To give everyone the chance to win GARMIN ONE, each athlete will be given a special bracelet, valid ONLY for the GARMIN ONE kilometre.

The bracelet will bear the athlete's race number. The wristband will be cut off if an obstacle on the course is not passed.

The winner of GARMIN ONE cannot be the same as the overall winner. In this case the winner will be the athlete with the second best time.

## INFERNO SERIES

Participants in the PRO category of INFERNO are automatically entered in the INFERNO SERIES, which is the sum of all INFERNO races of the year.

The ranking is given by the sum of the points collected in each stage according to the rules of the Italian OCR Federation and the Italian OCR Championship.

For the final classification, points are added up and participation in all stages is mandatory for the final classification and prize-giving, which takes place during the last stage. There are prizes for the overall winners, for each age category and for the teams, the prizes are communicated on the event webpage.

Whoever participates in all INFERNO stages in a year, in any category (OPEN or PRO) is entitled to the medal which is given during the last stage of INFERNO SERIES,

## OPEN HELL (with NON-competitive sports medical certificate)

Participants in OPEN HELL have no obligation to overcome the obstacles, which they can attempt an infinite number of times. They must assess the obstacle and their own ability to overcome it before proceeding to attempt the obstacle. Participants in the OPEN HELL category are equipped with a timing chip, the ranking will be based on the arrival time but will not be valid for FIOCR rankings, qualifications and ranking.





In the OPEN HELL category, the current health regulations or, for illustrative purposes, the spacing must be applied in any case.

No prizes will be awarded in the OPEN HELL category.

The organisation adheres to the sporting ethics charter of the Region of Tuscany, which promotes fair behaviour and mutual aid. Organisation staff will monitor the course and obstacles to ensure that the race proceeds smoothly and in accordance with the rules. In the event of non-compliant behaviour, the staff may report the bib number to the Organisation and the competitor may be disqualified even if he/she finishes the race. The course and the obstacles are designed in such a way as to limit the waiting time in front of each obstacle as much as possible. However, in the event of waiting, the organisation expects each participant to behave in a fair and polite manner. We remind you that INFERNO is a potentially dangerous obstacle race and the safety of the participants is the Organisation's top priority.

The Organisation reserves the right to modify the course or close individual obstacles at any time. Every participant is expected to behave in a fair and sporting manner!

Disrespectful or offensive behaviour towards staff, volunteers or judges may be punished by disqualification from the race and reporting for further sanction to Federazione Italiana OCR.

## **PARTICIPATION REQUIREMENTS**

Participation is open to women and men of all nationalities aged 16 years and over on the day of the race. Participation from the age of 13 years will be allowed for the shorter distance races.

## **MEDICAL CERTIFICATE**

For participation in the OPEN category, a sports medical certificate for recreational activity (non-competitive) is required. For participation in the PRO category (competitive), a sports medical certificate for competitive activity (type B1) is required, valid on the date of the race or drawn up no more than 12 months previously. Italian athletes must send a copy of their valid medical certificate for competitive activities, in accordance with the electronic procedure described on the race website. The medical certificates accepted are those that correspond to model B1.

Participation will not be allowed for those who only present a membership card of a sports federation, RUNCARD or other sports promotion body, not accompanied by a medical certificate. Foreign athletes must have the certificate made available by the organisation at [www.infernorun.it](http://www.infernorun.it) completed, stamped and signed by a doctor.

The organisation reserves the right to refuse to accept a medical certificate which is illegible or unclear and consequently not to allow participation in the race.

## **LIBERATORY**





At the time of registration, on [www.infernorun.it](http://www.infernorun.it), those wishing to participate in the INFERNO sign the knowledge and acceptance of these regulations and the relevant disclaimers, GDPR and privacy information available as an attachment to these regulations.

Additional releases and health certificates may be requested where required by the regulations in force on the date of the event.

## **REGISTRATION PROCEDURES**

The first registrations will be treated more favourably than the last ones. The [infernorun.it](http://infernorun.it) website lists the minimum registration fees required.

The registration fee includes

- Timing service with microchip
- official T-Shirt (size subject to availability) INFERNO;
- bag deposit service (if sanitary regulations permit)
- Shower service (if permitted by health regulations)
- refreshments or water points along the route (if and as health regulations allow)
- Swag
- Insurance cover

The registration procedures are indicated on the official website [www.infernorun.it](http://www.infernorun.it). In order to proceed with registration, the following are required: personal data, acceptance of privacy, regulations, health waiver, copy of medical certificate and payment of the registration fee in the prescribed manner.

Registrations can only be made online at [www.infernorun.it](http://www.infernorun.it) and the accepted methods of payment are indicated on the website.

The organisation reserves the right to close or reopen the registration at any time it deems appropriate, and in any case by giving notice on [www.infernorun.it](http://www.infernorun.it).

Registration will not be cancelled or refunded for any reason that prevents the member from participating.

In the event of cancellation of the event for reasons related to the epidemiological and health emergency from Covid-19, members will be granted a voucher to register for an event in the following 12 months or, at their option, a refund of 100% of the amount paid net of payment processing fees on the platform used.

The change of category, from OPEN to PRO is regulated as follows:

- 20 euros for changing from OPEN to PRO (if places are available)
- no cost for changing from PRO to OPEN

The change of ownership (change of participant's name) is regulated as follows:





- 15 euros for change of ownership up to 15 days before the event
- no change in the last 14 days

The change of ownership can be done directly on the registration platform by logging into your personal area.

For transfer to another INFERNO competition while keeping the same ownership:

- 20 euros for transferring ownership up to 15 days before the event
- no transfer in the last 14 days

For transfer to another INFERNO race it will be possible to do it on the registration platform, by accessing your personal area. Other ways of managing change of category, ownership and transfer to another race will be available on the registration platform.

## **ENVIRONMENTAL SUSTAINABILITY**

The Organisation and its partners respect environmental sustainability in all aspects of their activities. Therefore, all participants and people involved in the event are required to protect the environment. Compliance with legal regulations relating to the environment is an essential condition for taking part in the event. This concerns in particular waste management, soil conservation, water conservation and pollution control. Specific containers for waste separation will be provided and all participants are invited to actively participate in waste collection. A shoe collection service will also be provided.

## **RACE BIBS AND RACE PACKAGE COLLECTION**

The race-bibs and the race pack can be collected at the INFERNO Village on the day of the race or in other ways that will be communicated. The race-bibs can also be collected by third parties, with a written proxy and a photocopy of a valid ID of the delegating person. Collection by third parties may be prevented by health regulations. The race bib is strictly personal, cannot be tampered with and is not transferable to anyone.

## **TIMEKEEPING AND TIME LIMITS**

Participants in the race will be equipped with one or more chips for recording their race time; an order of finish will be drawn up on the basis of the time recorded. The measurement of times and the processing of the finishing orders will be carried out electronically and failure to return the transponder chip may result in a charge of up to € 10 for the participant.

The time limit is set for each race and communicated at the start. Beyond this time the organisation will not guarantee the complete safety of the race course and timing will not be continued. Any participant who fails to respect this limitation will be recorded as "NOT COMPLETED" in the results list. In any case, the race can be completed by all participants crossing the finish area.





## **BAG STORAGE, CHANGING ROOMS AND SHOWERS**

Changing rooms and bag storage, where such services are permitted by government and health regulations in force on the date of the race, are available to participants near the finish/start area. The shower service, if available, may be subject to waiting times depending on the number of participants. In this case we recommend appropriate and civilised behaviour while waiting.

The organisation accepts no responsibility for personal items unattended or forgotten in these areas or for theft or damage.

## **STARTING PROCEDURES**

Athletes taking part in the competitive race will start first, in one or more groups (bolge) depending on their total number and the health regulations in force. The evaluation of the number of PRO and OPEN HELL groups will be decided by the organisation on the basis of the number of participants, obstacles, safety and health regulations in force.

The Organisation reserves the right to modify the procedure and the starting times to improve the fluidity of the race. In this case, changes will be communicated in good time.

## **ATHLETE RESPONSIBILITY**

The athlete is obliged to keep informed about the rules, the way to overcome the obstacles, the details of the event communicated on the official website of the event.

The registered athlete is responsible for the ownership and custody of his race bib, acquiring the right to use all the services mentioned in these regulations and/or subsequently communicated.

a) Anyone who, without regular registration, takes part without a race number, in addition to being held responsible for damage to persons or property, including himself, will incur sporting sanctions under the competence of the federal bodies and may be liable to the criminal sanctions provided for the crime of "theft" (art. 624. criminal code).

b) Anyone who, without regular registration, takes part in the event with a counterfeit bib number or in any case one which does not conform to the allocation, in addition to being liable as indicated above, will incur sporting sanctions and may also be liable to the criminal sanctions provided for the offence of "theft" (art. 624. criminal code), or, alternatively, for the offence of fraud (art. 640 criminal code). In cases a) and b), participants may be liable to the penalties provided for the offence of "failure to comply with the provisions of the Authorities" (Article 650 of the Criminal Code). The aforementioned cases will only be found after verification of photographic and/or video documentation.





## **PRIZES**

Prizes in kind will be awarded to the first three men, the first three women and the first three teams in the competitive race. If logistics and time permit, prizes will also be awarded to the first in each age category.

The prize-giving ceremony will take place approximately two hours after the end of the competitive race at the finish area. The final results and the alphabetical order of arrival will be published after the end of the race on the official website and/or on the timing service website.

Prizes, if available, will be handed out only and exclusively to those who are present at the ceremony, they will not be handed out later or sent out.

The prize-giving ceremony will in any case be carried out in accordance with current health regulations.

## **MEDICAL SERVICE**

The organisation will provide an adequate medical service on the route and at the starting and finishing points. Ambulances, first-aid facilities and paramedical services, located at key points along the route, will provide the appropriate medical service to all participants. Doctors and paramedical staff are authorised to prohibit injured, overtired or wounded participants from continuing the race in order to ensure the health safety of all participants.

## **FINAL WARNINGS**

The event takes place in all weather conditions, without prejudice to the right of the organisation to suspend the race for reasons related to the safety of participants or public order.

The organisation reserves the right to cancel the event, postpone it, anticipate it or postpone it and to modify the present regulations at any time for reasons that it considers appropriate for a better management of the race or for the health of the participants, at its own indisputable judgement.

Any changes to services, places and times will be duly communicated to participants and will be posted on the website [www.infernorun.it](http://www.infernorun.it).

# INFERNO SHORT TEAM

INFERNO organises an OCR race for freely composed teams on a course of about 7 km with about 15 obstacles to overcome together. It is not a relay race.

These regulations are to be considered an integral part of the general regulations (INFERNO 2021 regulations) which, with the athletes' guide, form a single body of law.

### RACE, RULES AND PENALTIES

INFERNO TEAM will have team starts, i.e. the team members will start together. The time will be recorded with an electronic chip and the time recorded by the last team member will be used. The start and finish of the team members must be within 60" of each other, i.e. no more than one minute can pass between the first and last recorded time. The team starts, runs and finishes together.

We suggest each team to wear the same jersey or the same colours or a distinctive sign of the team to facilitate the judges and volunteers in carrying out their tasks. .

Each obstacle must be passed together following the same line, i.e. each team may occupy a maximum of one lane at each obstacle. Without changing the lane chosen by the first athlete, therefore, the second athlete of the team will proceed to overcome the obstacle as soon as the first has touched the bell at the end of the lane and so will the third athlete of the team.

There will be obstacles on the course that must be overcome by each team in co-operative mode. As an illustrative but not exhaustive example, there will be transports that must be performed by the whole team simultaneously, balancing acts or other tests that involve the whole team.

Each team member will have 3 bracelets. In order for the team to enter the ranking, each athlete of each PRO team must have at least one bracelet still on his wrist at the time of the Penalty Loop. Each suspended obstacle will only have 1 attempt. Each failure or failure to pass an obstacle will result in 1 wristband being cut from the wrist of the athlete who failed it.

Lost wristbands can be recovered through the Penalty Loop system. The Penalty Loop will be performed by teams.

Participants of the OPEN race will follow the same instructions but will not be obliged to pass the obstacle or cut wristbands.





#### STARTING PROCEDURE

In order not to create crowds, starting times for each team will be drawn up and communicated.

The starting times will be published on the event website and may vary on the day. Unless otherwise indicated, we recommend that you arrive at least 90 minutes before the scheduled starting time.

#### PARTICIPATION REQUIREMENTS

The event is open to anyone aged 13 years or over on the day of the race, women and men of all nationalities. Minors must have permission from their parents or guardians. You can only take part once in each race; you must register for the race, not for the battery.

FUNDAMENTAL REQUIREMENT is the presentation of a valid medical certificate for competitive activity and a waiver for minors. A non-competitive sports certificate is sufficient for OPEN participation.

#### TEAM PRO and OPEN CATEGORIES

3 women team

3 men team

mixed team (2 women and 1 man or 2 men and 1 woman)

#### MODALITIES OF CHANGE OR TRANSFER OF OWNERSHIP OF REGISTRATION

Each team will be able to change one (only one) participant without additional cost until September 30th. After the first change every following change will cost 10 euros. From October 1st every change of participant, even if it is the first one, will cost 10 euros.

INFERNO reserves the right to modify part or all of this document. Always check the updated document.





# INFERNO SPRINT

INFERNO presents a sprint race inspired by the Sprint League circuit of FIOCR - Federazione Italiana OCR, with the aim of widening the proposal of obstacle racing in Italy and offering variety in difficulty, distances and tracks that this sport requires and is characterised by.

## RUN LIKE HELL

These regulations are to be considered an integral part of the general regulations (INFERNO 2021 regulations) which, together with the athletes' guide, form a single body of law.

## COURSE AND OBSTACLES

The total length of the course can be between 400m and 1000m.

The race course will be clearly delineated by means of webbing, barriers or other means in order to exclude or minimise errors and cuts in the course, whether voluntary or involuntary. The course will be on mixed terrain and may have a positive altitude difference.

The number of obstacles will be between 8 and 15.

## RACE, RULES AND PENALTIES

INFERNO SPRINT will have single or multiple time trial starts.

The time will be recorded with an electronic chip.

Each obstacle must be overcome with a maximum of three (3) attempts. If a competitor does not pass the obstacle after the three attempts, a time penalty will be applied. He may only proceed further after the three mandatory attempts.

Time penalties will vary depending on the difficulty and the time allowed for the obstacle. The penalty will always be a longer time than three real attempts in order to discourage simulations. The penalties can range from 30 seconds to 4 minutes and will be communicated before the race on social channels, in the athletes' guide and on the INFERNO website.

It will be possible for INFERNO to insert a time limit (time cap) for organisational needs.

## STARTING PROCEDURES

In order not to create crowds, starting times will be drawn up and communicated.

The starting interval may vary according to the number of participants: for example, an interval of 1 to 5 minutes.

The starting times will be published on the event website and may also vary on the day. Unless otherwise indicated, we recommend that you arrive at least 90 minutes before the scheduled start time.





#### PARTICIPATION REQUIREMENTS

The event is open to anyone aged 13 years or over on the day of the race, women and men of all nationalities. Minors must have permission from their parents or guardians. You can only take part once in each race; you must register for the race, not for the battery. FUNDAMENTAL REQUIREMENT is the presentation of a valid medical certificate for competitive activity and a waiver for minors.

#### PROCEDURES FOR CHANGING OR TRANSFERRING REGISTRATION RIGHTS

The change of ownership (change of participant's name) is regulated as follows:

- 5 euros for change of ownership up to 30 days before the event (up to 09/09/2021 for MUD)
- 8 euros per change of ownership up to 15 days before the event (up to 25/09/2021 for MUD)

no change in the last 14 days (from 26/09/21 for MUD)

Race change not foreseen.

#### AGE CATEGORIES SPRINT PRO

13/14 - 15/17 - 18/24 - 25/29 - 30/34- 35/39 - 40/44 - 45/49 - 50+

#### OTHER INFO

Registration includes race number and timing chip, refreshments.

By asking to take part in the INFERNO race, I declare that I am aware of the characteristics of the race, that I am NOT under the influence of medication, alcohol or drugs; that I am physically prepared and that I am aware that only a careful personal evaluation of my own condition is a guarantee of safety for me and for others. .

I exempt Andromeda Sport SSD arl, its organisers and its staff from any civil and penal responsibility and from any compensation for physical, moral and material damages that may occur to me before, during and after the organised activity, even if such damages are caused by third parties and/or other participants. According to the articles 1341 and 1342 of the C.C. I explicitly approve the clause concerning the exemption of responsibility of Andromeda Sport SSD arl. I assume all responsibility for actions taken during the activity and for the consequences that may arise from such actions, both civilly and criminally. I totally exonerate Andromeda Sport SSD arl from any responsibility for damages to my person and/or to third parties and/or things caused by me. I assume full personal responsibility for my state of health.

I also declare to grant the Organisation, or whoever on its behalf, the rights of images, photos and videos related to the race, to authorise the treatment of my personal data according to art. 13 of the law 675/96 and following, to be aware of the penal sanctions provided in case of untruthful declarations and falsity in the acts (art. 76 d.p.r. 445/2000 and art. 489 of the penal code).

Furthermore, the undersigned by signing at the bottom of the page

Declares that he/she has carefully read every part of the Rules and Regulations of the event and has accepted them in full and without reservation.

I declare that I am fully aware of all the characteristics and specificity of the event, the route, the difficulties and the length of the course, which is in the mountains with possible difficult weather conditions (such as, for example, cold, wind, rain, snow, poor visibility, etc.). I am aware of the risks to my personal safety connected with the competition; I am an expert in mountain running/trail running/skyrunning/outdoor running and I am aware that participation in this event requires specific preparation and a real capacity for personal autonomy which I attest to possessing;

I declare that I do not use doping substances and that I am in possession of a medical certificate attesting to my fitness for sporting activity, that I am in good health and exonerate the organisers from all liability relating to and resulting from the verification of said fitness;

Undertakes, under penalty of exclusion from the event, to behave in accordance with the principles of fairness and sportsmanship during the race and not to behave in any way contrary to the law and the rules of the regulations that may endanger his own safety or that of others; also undertakes to behave in an environmentally friendly manner during the race, according to the principle of "running without leaving a trace";
