

Laborde Earles F250 Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN.

In return for the opportunity to participate in the Laborde Earles F250 Giveaway described herein (the "Giveaway"), Laborde Earles, Inc. ("Sponsor") requires your agreement to comply with and be bound by the terms and conditions set forth below (the "Official Rules"):

OFFICIAL RULES

1. **PERIOD.** The Giveaway will begin on **April 5th 2025 at 12:00 a.m.** Central Time ("CT") and end on **February 17th, 2026** at 11:59 p.m. CT (the "Giveaway Period").
2. **ELIGIBILITY. NO PURCHASE NECESSARY TO ENTER.** Only legal residents of the United States who are 18 years of age or older at the time of entry and live within the state of Louisiana are eligible to participate in this Giveaway. Past and current employees and immediate family members (spouses, parents, siblings and children) of employees of Laborde Earles and its respective parents, subsidiaries, affiliates, directors, officers, governors, employees, agents, and any household members of all such persons (whether or not related), anyone employed at a Law Firm at time of entry through winner announcement dates are not eligible to enter. The Giveaway is subject to all applicable federal, state, and local laws and regulations and is void wherever prohibited or restricted by law. The winner shall be required to sign a Release, an Affidavit of Eligibility, a Prize Acceptance Form and any other form/document deemed necessary by Sponsor in order to receive the prize ("Declaration"). The arbitrator shall be selected by mutual agreement of the parties, if possible, and shall be a resident of Louisiana. If the parties fail to reach agreement upon the appointment of an arbitrator within thirty (30) days following receipt by one party of the other party's notice of desire to arbitrate, the arbitrator shall be selected from a list or lists of persons submitted by the AAA. The selection process shall be that which is set forth in the AAA Commercial Arbitration Rules then prevailing, except that if the parties fail to select an arbitrator from one or more lists, AAA shall not have the power to make an appointment but shall continue to submit additional lists until an arbitrator has been selected. Under no circumstances will Entrant be permitted to obtain any punitive, incidental, special, consequential and/or other damages, including without limitation lost profits (collectively, "Special Damages") to an Entrant; and Entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
