Country Profile Nepal





STOP CHILD EXPLOITATION!

Children in Nepal are extremely vulnerable to sexual exploitation arising out of prevelant unsafe migration, trafficking, child marriage and online sexual abuse and exploitation.

40% of Nepal's population is under the age of 18. The country is one of the most economically vulnerable nations in South Asia. 1.1 million children are found to be engaged in child labour. Children in Nepal are extremely vulnerable to sexual exploitation arising out of prevelant unsafe migration, trafficking, child marriage and online sexual abuse and exploitation. Nepal currently ranks 94th out of 194 countries on the Global Cyber Security Index.3 Cases of online grooming by foreign tourists and live streaming of child sexual abuse material are major risks faced by children.

Our Projects

Safety for Children and their Rights OnLine (SCROL)

Gandaki province

SCROL in Nepal works to protect children and prevent online child sexual exploitation (OCSE) by enabling systemic changes that ensure a safe online environment. The project works with the law enforcement agencies, relevant government departments and the private sector to build their capacities to respond to OCSE and strengthen implementation of laws and facilitate policy changes. Children are empowered to advocate for a safer online environment, with sensitisation through peer support groups.

Step Up the Fight Against Sexual Exploitation of Children (SUFASEC)

Project location: Kathmandu city

As part of the Down to Zero Alliance, the SUFASEC project in Nepal works to strengthen systems to protect children from online child sexual exploitation, empower children to access their sexual and reproductive health and rights (SRHR) and enable a safe online environment. The project works with multiple stakeholders such as school teachers, parents, law enforcement agencies and government representatives to create platforms for knowledge sharing, sensitisation and systems strengthening.

Achievements 2023

- 1. The Government of Nepal amended a law to establish trial courts for the first time in all the 77 districts of Nepal exclusively to hear cyber crime cases, and a local government unit allocated a budget towards awareness raising on OCSE.
- 2. The Community Police in Nepal have begun to integrate awareness against online child sexual exploitation (OCSE) into their activities.
- 3. Children advocated directly with the Minister of Women, Children and Senior citizens in Nepal to include addressing OCSE in the 16th National Action Plan presenting the minister with a memorandum highlighting the need for inclusion online safety learning in the national education curriculum, a special unit for child protection under the Cyber Bureau and 8 other advocacy asks.
