2. Application

The participant is entering _____ samples of wine for the international competition under the specifications indicated on the back of this application and contract by **no later than 11 April 2008.**

3. Quantity and packaging

Participant must provide 6 labeled 0.7 or 1/1 l bottles of each sample; for predicate, special and liqueur wines from 0.25 to 0.75 l in original packaging. Samples are sent by the participant at his or her own expense (transportation and forwarding costs, customs formalities). In the package each sample must be accompanied by the invoice in 6 copies. Each estimate should state the package value and include the statement "Free of charge for the International Wine and Spirits Competition in Ljubljana". Participant must send the samples to Gospodarsko razstavišče d.o.o., Dunajska cesta 18, 1000 Ljubljana, by no later than 16 May 2008.

Samples have to be accompanied by the analysis conducted by an institution registered for this type of activity. The analysis must include the following information: alcohol, sugar, total acidity, volatile acidity, free and total SO₂. On the basis of the analysis the wine is classified into the appropriate category.

4. Price

The entry fee is **130 €** per sample. The entry fee includes the costs of work of the committee and the costs of producing the catalogue, medals and certificates.

5. Payment

After receiving this application and contract Gospodarsko razstavišče d.o.o. will issue an invoice that must be paid fully and without deductions within the period stated in the invoice. Judgment of the samples is contingent upon payment within the stated period.

6. Medals and certificates

Gospodarsko razstavišče d.o.o. undertakes to, after the received payment (item 5), pass on the received wine samples to the international tasting committee for judgment and send awards to the awarded participants. Wines participating in the competition can be awarded the following medals and certificates in accordance with the international wine judging rules: great gold medal, gold medal, silver medal, title WORLD CHAMPION, awarded to the highest-quality wine in each category, title "Country winner" for the highest scoring wine from an individual country, trophy "Vinofed", awarded to the wine judged on the basis of the VINO FED rules, diploma "Akos Asvany" for the highest scoring liqueur wine, trophy "TSUKAMOTO" for the highest scoring red wine.

Each participant whose samples will be awarded can pick up medals and certificates at Gospodarsko razstavišče, d.o.o. or they can have them mailed to them.

7. Catalogue with results

The results will be published in the official catalogue of the international competitions and on the Gospodarsko razstavišče website.

8. Special warning

We ask you to **strictly follow the application and sample arrival deadline** to avoid late arrival of samples to the evaluation. Entered samples sent to the competition too late and samples for which the entry fee has not been paid in accordance with the terms of this application and contract will not be judged. Gospodarsko razstavišče d.o.o. does not refund the entry fee for entered samples that arrive too late and for the samples that were not received.
