A wine sample consists of at least six labeled bottles in original packaging. If the **volume of bottles** is less than 0.75 l, the number of bottles should ensure a total sample volume of **at least 4.25 l/sample**.

**Samples are to be sent to** the following address at the expense of the sender: Gospodarsko razstavišče, Dunajska cesta 18, 1000 Ljubljana, Slovenia. **Deadline for arrivals is May 15 2009.**

Samples should be **supplemented by an analysis** issued by an authorized organization. The analysis should contain the following data: alcohol, sugar, total acids, volatile acids, free and total SO<sub>2</sub>. Wines shall be sorted into corresponding groups on the basis of those analyses.

3. Price and payment

The participation fee includes the costs of the commission, catalog manufacture and medals, diplomas and plaques. **Prices are valid upon concurrent application of samples.**
