In case of samples' delivery by air, you should clearly specify on the shipping document CIF delivery condition.

WARNING!

Every submitted sample has to be a part from a bottled commercial batch of at least 1000 litres. Just in particular situations, such as old collection wines, ice wines, botrytized wines - samples can be submitted for bottled commercial batches of at least 100 litres.
