

About NEXERA:

NEXERA is the first exclusively wholesale telecommunications operator in Poland, which develops a modern fibre optic NGA (Next Generation Access) access network of large-scale and high bandwidth (min. 100 Mb/s). The company builds and manages the fibre optic network in 14 areas of central and north-eastern Poland, concentrated in four Regions: Łódzki Region; Świętokrzyski Region; Kujawy, Pomorze & Mazowsze Region and Warmia & Mazury Region. NEXERA fiber optic access network is based on the latest FTTH technology, which offers stable Internet access for small towns and villages.

NEXERA's mission is providing new opportunities for better life, work and business for residents. It accomplishes this goal by building and managing a fiber-optic access network and providing high-speed, stable and reliable access to the digital world in Regions that have not been connected to a broadband network until now.

NEXERA conducts its activities under one of the most important infrastructure projects of the Polish government - the Digital Poland Operational Program (POPC).

About the Digital Poland Operational Program (POPC):

The goal of the Digital Poland Operational Program is to eliminate territorial differences in access to high-speed broadband Internet and to counteract the digital exclusion of European Union citizens. NEXERA is a beneficiary of 14 competitions conducted as part of the Digital Poland Operational Program (POPC). By 2021, thanks to NEXERA's activities, more than 670,000 households and almost 3,000 schools and educational units will be within the range of the most modern fibre network. All schools and over 311,000 farms from this group will be covered by the NEXERA network thanks to co-financing from European funds under POPC in the amount of over PLN 597 million. The total value of the investment is about PLN 1.5 billion and the remaining funds come from NEXERA shareholders.

NEXERA Group:

The NEXERA infrastructure group consists of: Nexera Holding Sp. z o.o. (a company managing the Group's operations and the owner of the Group's operating companies) and Nexera Sp. z o.o. (wholesale operator and fibre optic network owner). Nexera Fiber Sp. z o.o. - SPV. NEXERA's shareholders are companies that have been active on the global telecommunications market for years: Infracapital and Nokia.

#REGIONYNEXERY Report

Survey on remote work and online teaching

In 2020, NEXERA conducted a survey on the experience of Poles related to the transition to remote work and online learning due to the development of the COVID-19 pandemic. The study was conducted by InsightOut Lab at the request of NEXERA between 27 and 30 March 2020 and shows how companies and employees coped with the new online reality and how Polish schools organized the process of remote teaching for children.
