INVESTMENT OBJECTIVE AND STRATEGY

The Investor Fund is a Peso-denominated balanced Unit Investment Trust Fund structured as a feeder fund and aims to achieve for its participants, high growth and high income primarily by investing in the Metro Balanced Fund. The Fund's composite benchmark is composed of 60% Philippine Stock Exchange Index and 40% Markit iBoxx ALBI Philippines 1-5.

CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

The METRO ASPIRE BALANCED FEEDER FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want high growth and high income primarily by investing in Metro Balanced Fund.
- Recommended investment horizon is at least five (5) years
- Participation in the Investor Fund shall be open to Filipino individuals, resident and non-resident aliens and corporate accounts.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk:	The possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
Market/Price Risk:	The possibility for an investor to experience losses due to changes in the market prices of bonds and stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the bonds and stocks/equities.

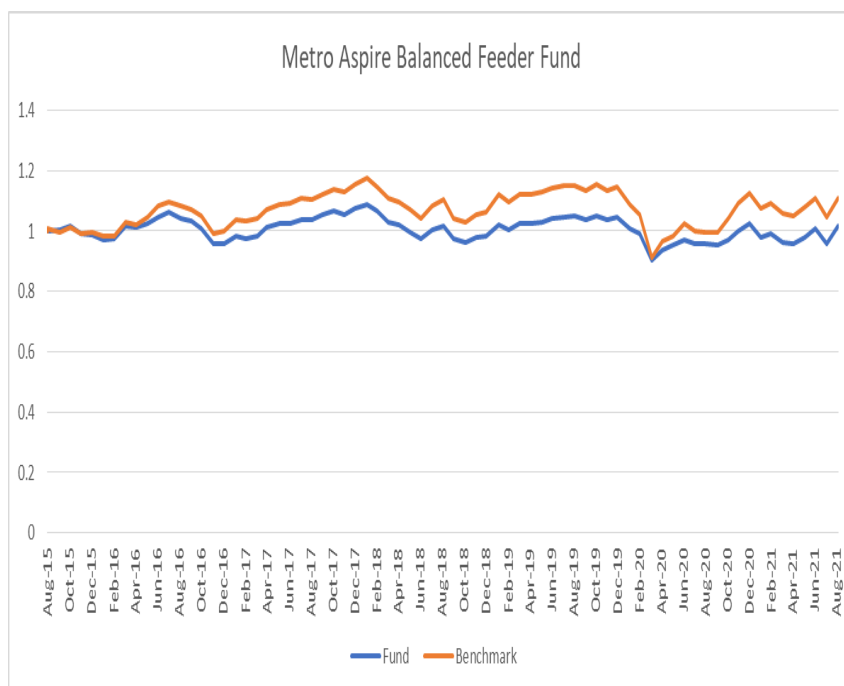

⁵ Benchmark return was based on the original benchmark of 60% Philippine Stock Exchange Index (PSEi) and 40% HSBC Local Currency Bond Index (HSLI) 1-5 years (net of taxes) since inception, and was changed to 60% PSEi and 40% Bloomberg Philippine Sovereign Bond Index 1-5 year (BPHIL15) Adjusted effective May 2016.

The BPHIL15-Adjusted Index was tentatively discontinued when the GS pricing basis shifted from PDST -R2 of PDEX to BVAL of Bloomberg effective October 29, 2018. The Fund used, an equivalent benchmark namely, the BPI Philippine Government Bond 1-5 Year Index (from October 30, 2018 to December 31, 2020) and Markit iBoxx ALBI Philippines 1-5 (from January 2020 until October 20, 2020). Effective October 21, 2020, the Fund benchmark is 60% Philippine Stock Exchange Index (PSEi) and 40% Markit iBoxx ALBI Philippines 1-5.

OUTLOOK AND STRATEGY

Foreigners were back as net buyers in August to the tune of about \$32.7 Mn- reversing the continued net outflows for the past 21 months in the local stock market thus debunking the sluggish ghost month expectations. The PSEi trekked steeply by +585pts or +9.3% MoM to end at 6,855 with the average daily turnover increasing to \$150 Mn from the previous month's \$117 Mn brought by the PSEi and MSCI rebalancing that occurred. The Philippine bond market yield curve, however, rose by 5-20 bps from the belly to the longer end as the BSP expectedly kept its key rates unchanged.

GDP results for 2Q shed a light in the economic recovery of the country at +11.8% YoY while QoQ figure of -1.3% was due to the ECQ experienced in the first quarter. Food and non-alcoholic beverages climbed sharply for the month thus pushing the CPI print for August to accelerate to 4.9% from July's 4% figure. On the PSEi front, the index was reconstituted with ACEN and CNVRG replacing DMC and EMP. The Philippine local stock market also debuted its third listed REIT, FILRT- at the IPO price of P7, FILRT guided about 6.6% dividend yield for 2022. Providing some color on the local fixed income market; the auctions for the 7-, 10-, 20-year bonds were successfully received except for the 12-year bond in which the Bureau of Treasury rejected and stated that the bids were "unreasonably high" as investors turned defensive.

The market has yet to see the effectiveness of the newly introduced granular lockdowns of the government, still backed by the persistent vaccination drive in order to fight the pandemic. Moreover, the monetary policy-infused liquidity has kept short-term rates well-anchored while corporate fund raising activities such as RCR and MREIT could prompt near-term profit taking in the PSE.
