# **INVESTMENT OBJECTIVE AND STRATEGY**

The Fund is a dollar-denominated long-term bond Unit Investment Trust Fund that aims to achieve for its participants income generation and capital appreciation by investing in a diversified portfolio of investment grade fixed income securities issued within the Asian region with a maximum weighted average duration of eight years. The Fund's composite benchmark is composed of 90% JP Morgan Investment Grade Total Return Index (JACIIGTR) and 10% Philippine Dollar Deposit Rate Savings Deposit (PPSDU\$).

#### **CLIENT SUITABILITY**

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

#### The METRO\$ ASIAN INVESTMENT GRADE BOND FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital appreciation over the long-term by primarily investing in a portfolio of investment grade dollar-denominated fixed income securties.
- •Recommended investment horizon is at least five (5) years
- •Participation in the Fund shall be open to Filipino individuals, resident and non-resident aliens and corporate accounts.

Interest Rate

The possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price The possibility for an investor to experience losses due to changes in the market prices of bonds. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the bonds.

The possibility for an investor to experience losses due to the inability to call or convert expert into each immediately.

Liquidity Risk:

Credit Risk / The possibility for an investor to experience losses due to a borrower's failure to pay principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of fixed income security which the borrower issued. This inability of the borrower or counterparty to make good on its financial obligations may have resulted from adverse changes in its financial condition thus, lowering credit quality of the security, and consequently lowering the price (market/price risk) which contributes to the difficulty in selling such security.

Reinvestment
Risk:

The possibility of having lower returns or earnings when funds mature and are reinvested. Investors in the UITF who redeem and realize their gains run the risk of reinvesting their funds in an alternative investment outlet with lower yields. Similarly, the UIT fund manager is faced with the risk of not being able to find better yielding alternative

investment outlets as some of the securities in the fund matures.

Foreign The possibility for an investor to experience losses due to fluctuations in foreign exchange rates. The exchange rates depend upon a variety of global and local factors, e.g. interest rates, economic performance, and political developments.

Country Risk: The possibility for an investor to experience losses arising from investments in securities issued by/in foreign countries due to the political, economic and social structures of these countries. There are risks in foreign investments due to

the possible internal and external conflicts, currency devaluations, foreign ownership limitations and tax increases of the foreign country involved which are difficult to predict but must be taken into account in making such investments.



# **INVESTMENT POLICY**

The Fund may be invested and reinvested in the following instruments:

- USD-denominated deposits
- Other money market instruments
- Tradable Philippine sovereign, quasi-sovereign and corporate fixed income securities
- Tradable fixed income securities issued by other sovereign countries and foreign quasi-sovereign and private institutions
- Tradable US\$-denominated subordinated fixed income instruments issued by corporations and financial institutions
- Other investments allowed under BSP regulations

#### **OUTLOOK AND STRATEGY**

Global markets remains resilient amid Covid-19 Delta variant posing risk to growth outlook as vaccinations continue to be effective in preventing critical complications among patients; with some countries already announcing booster programs to support further re-opening of their economies. US inflation accelerated by 5.4% year-on-year in line with both market expectation and prior month's print. However, slower increase of 0.5% was seen month-on-month due to lower prices of used cars and apparel. Core inflation which excludes food and energy prices rose by 4.3% year-on-year (vs 4.5% prior month) and 0.3% month-on-month (vs 0.9% prior month). Federal Open Market Committee remains accommodative to support economic recovery; but could start tapering monthly bond purchase program by the end of the year. Fed Chair Powell during his speech at the Jackson Hole Symposium cited that while the US economy is at a strong path forward, they are still looking at incoming data from the labor market. Moreover, with inflation considered as transitory and is mainly driven by supply constraints, they are not in a hurry to raise interest rates as tapering too aggressively could derail progress. Market participants will now closely monitor Federal Open Market Committee September meeting for further clues on the tapering and the release of the committee's rate forecasts.

US Treasury yields climbed higher by 1-8 bps month-on-month as investors continue to price gradual monetary easing hinted by the Fed. Overall, global sovereign and corporate bond yields rose for the month with data showing economy is still expanding that point towards minimal impact of the Delta variant. Asian investment grade bond spreads narrowed and prices were marginally higher attributable to a strong demand for better yielding assets. Bond yields are expected to rise as the Fed is anticipated to gradually wind down its ultra-easy monetary stance by tapering asset purchases possibly to start by year end.
