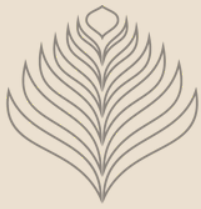
### Disclaimer

### Terms and Conditions of Membership

- There will be a one-time initial set-up fee in the amount of \$75. This fee is non-refundable.
- Initial terms of the membership contract are for a minimum of 6 months.
- Monthly memberships are non-transferrable and cannot be shared.
- Banked funds: All membership fees with the exception of a \$75 sign up fee will be banked into your patient "wallet" for future use. Unused banked funds will accrue each month. Banked funds will not expire; however, cannot be refunded unless deposited AFTER a written 14 day cancellation notice. Banked funds can be used for any retail products, spa services or other services provided by Aesthera. Accrued or "banked funds" can be used after cancellation of a membership; however, the membership discounts and benefits will no longer apply.
- Monthly membership dues will automatically be charged to the credit/debit card on file monthly and remain in auto-renewal until a cancellation notice is received.

## Membership Agreement & Benefits

### Termination

Members may cancel your membership, with a 14-day notice, any time after the initial six-month contract requirement. Any remaining balance can be used towards services or products offered at Aesthera. Termination of your membership prior to the initial 6 month requirement can be requested but will result in a \$200 cancellation fee. A written 14-day notice must be provided to discontinue all memberships. Your membership will remain on auto-renewal until a written cancellation notice is given.

### Freezing membership

There may be times such as pregnancy, illness, relocation, military service etc. where a member may need to freeze their membership; but not want to cancel. Members may freeze their membership for 1-3 months. At this time they may use their banked funds, but will not be eligible for member discounts, until they have resumed full membership. Any variations due to unforeseen events will be examined on a case basis.

- Aesthera reserves the right to vary, add or amend services as they become available or no longer in use
- Aesthera reserves the right to change clinic policies, procedures or pricing with written notice that allows member ample time to change membership status
- Aesthera reserves the right to cancel a member's membership for any reason, including but not limited to non-adherence to this contract
