

Notice on the processing of personal data

ADAPTNOW closing event - Presentation of a roadmap for climate change adaptation of tourism in Val Pusteria

Personal data will be processed in accordance with EU Regulation 2016/679 (GDPR) for the following purposes:

For the documentation of the event (photo images and audio-video recordings) for organisational, institutional, archiving and communication purposes, and for presentations, documentation, creation of information material, communication activities and publications through any form and means, such as web pages and social networks. Eurac Research undertakes not to make any use of the images that could be detrimental to the dignity, reputation or decorum of the interested party.

Furthermore, the Data Controller may become aware of particular categories of personal data pursuant to art.9 GDPR (food preferences).

The legal basis of the processing is based on consent to the processing of personal data.

The data will be stored to have a historical memory of institutional events and activities and, if necessary, for any publications. In any case, the conservation will be carried out for a period of time not exceeding the achievement of the indicated purposes and/or in any case for the time strictly necessary for the fulfillment of the obligations required by law (articles 2946 ff. of the Civil Code), after which they will be destroyed or made anonymous. The provision of data is optional; however, failure to provide it could interfere with the correct performance of the purposes indicated above.

The data may be processed by authorized collaborators of the Center for Climate Change and Transformation, Eurac Research and may be published in relation to the event. Personal data may also be disclosed to other external service providers, who typically process Personal Data on behalf of Eurac Research as data controllers. To provide certain services, Eurac Research and the Free University of Bolzano jointly manage the Scientific Network South Tyrol platform which connects their respective computer centres. Eurac Research and the Free University of Bolzano are joint controllers of the processing of personal data processed in this context and, consequently, have entered into an agreement pursuant to art. 26 GDPR.

Personal data is usually processed mainly within the European Union. Some of the personal data may be transferred to recipients who may be located outside the EU but, in any case, only for purposes related to the performance of Eurac Research's institutional activities. Eurac Research ensures that the electronic and paper processing of personal data by recipients occurs in any case in compliance with the Applicable Regulations.

The interested party has the right to ask the Data Controller for access to the data concerning him, their rectification or cancellation, the integration of incomplete data, the limitation of processing, the portability of the data and to lodge a complaint i.a. to the national authority as well as to exercise the other rights recognized by the applicable law (articles 15 ff. GDPR). If consent has been given for the processing of personal data, the right to revoke it is recognized.
