ISC2026 brings together the organisations, experts, and ideas shaping this transformation through three days of knowledge sharing, practical learning, and high-level networking.

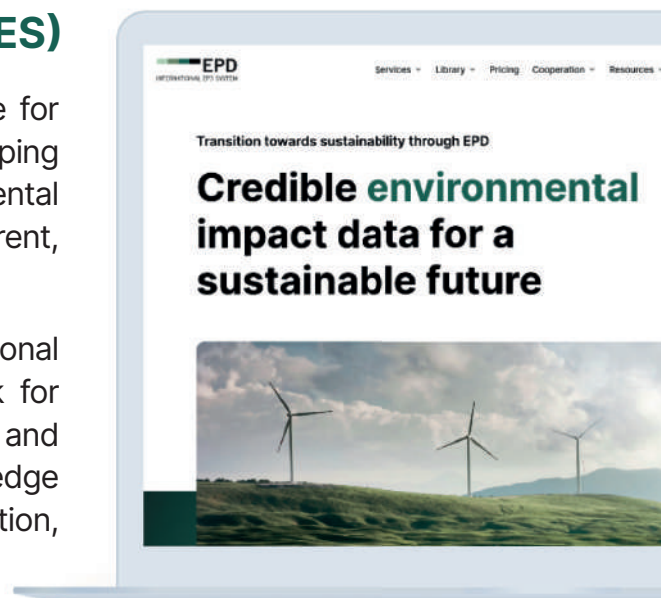

The International EPD System is a global programme for Environmental Product Declarations (EPDs), helping organisations communicate the environmental performance of products and services through transparent, verified, and comparable information.

Built on Life Cycle Assessment (LCA) and international standards, the system provides a robust framework for developing and publishing EPDs that can be trusted and used in decision-making, while supporting knowledge sharing, practical learning, practical learning, collaboration, and networking.

Independent verification and internationally recognised methodologies help ensure confidence in environmental information.

### ✓ COMPARABILITY

Common rules and consistent methodologies enable meaningful comparison between products and solutions.

Clear requirements, documented methodologies, and robust governance structure/framework support reliable and transparent communication.

### ✓ DECISION-READY INFORMATION

EPDs support real-world decisions related to procurement, sustainability reporting, investment, product development, and climate strategies.

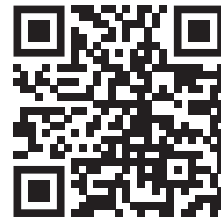
