Therefore Factory/Establishment will pay contribution at the ratio of Rs. 20:40 (Employees Rs. 20/ Employers Rs. 40) & to be remitted through online only.

#### LAST DATE TO PAY CONTRIBUTION: 15-01-2021 (CALENDER YEAR 2020)

Delay in payment of Contributions will attract penal interest at the rate of 12% for 1<sup>st</sup> 3 months and after 3 months 18% on the amount due, and inspections by the Welfare Commissioner.
