ORDER U/S 144 Cr.PC.

Whereas, it has been brought to the notice of the undersigned by the Block Medical Officer Markand/SNDJ District Bilaspur that one positive case of COVID-19 has been found in Ward No. 2, NAC Police Chowki Shri Naina Devi Ji, Tehsil Shri Naina Devi Ji at Swarghat, District Bilaspur H.P. Therefore, there is an imminent danger of spread of COVID-19 in the adjoining/other parts of District Bilaspur and to take strict measures to stop the further spread of COVID-19, which if not taken immediately, can pose grave danger to the lives, health & safety of the residents of the area.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area mentioned in No. HFW.BLS.MKD.(PH)-37/20-11894-898 of Block Medical Offices, Markand, is not practicable and possible and therefore, it is necessary and expedient to proceed under section 144 of the code of Criminal Procedure, 1973.

Whereas, in pursuance of Letter No. Rev. (DMC) (C) 20-2/2020 (COVID-19) dated 8th June 2020 issued by Principal Secretary (Revenue) to the Government of Himachal Pradesh Vide para No. 6 regarding closure of workplace directed as under:-

"If there are one or two cases reported, the disinfection procedure will be limited to places/areas visited by the patient in past 48 hrs. There is no need to close the entire office building/halt work in other areas of the office and work can be resumed after disinfection as per laid down protocol. However, if there is a large outbreak, the building/block is adequately disinfected and is declared fit for reoccupation."

And therefore, in view of the above circumstances and as per the recommendation of Block Medical Officer Markand/SNDJ, District Bilaspur as conveyed vide his office letter No. HFW.BLS.MKD.(PH)-37/20-11894-898 Dated 25-09-2020 received through post on dated 01-10-2020 and as a containment measure I, Husan Chand, Tehsildar currently holding the charge of Sub Divisional Magistrate, Shri Naina Devi Ji at Swarghat, District Bilaspur Himachal Pradesh, in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby that Ward No. 2, NAC Police Chowki Shri Naina Devi Ji, is no need to close the entire office building/halt work in other areas of the office and work can be resumed after disinfection as per laid down protocol.
