## ORDER

WHEREAS, in the wake of spread of Coronavirus (COVID-19), the Ministry of Home Affairs vide it's Order No. 40-3/2020-DM-I(A) dtd. 24<sup>th</sup> March, 2020, had ordered a Total Lockdown of 21 days throughout the Country from 25<sup>th</sup> March, 2020, in order to contain the spread of the said coronavirus;

AND WHEREAS, vide its subsequent orders of even number, the said Lockdown was extended from time to time till 31st July, 2020;

AND WHEREAS, the Ministry of Home Affairs vide its Order No. 40-3/2020-DM-I(A) dtd. 29<sup>th</sup> July, 2020, has extended the Lockdown only for the areas which are identified as Containment Zone in the Country upto 31<sup>th</sup> August, 2020 and has directed to re-open prohibited activities in a phased manner in areas outside Containment Zones;

NOW THEREFORE, in view of above and in exercise of the powers conferred under Section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order as under:

- No fake news or rumors shall be spread by any person related to the Coronavirus (COVID-19);
- 2. Movement of individuals shall remain strictly prohibited between 10:00 p.m. to 05:00 a.m. except for medical emergencies and essential services emergencies;
- 3. All the shops in Dadra & Nagar Haveli shall be allowed to remain open from 05:00 a.m. to 10:00 p.m.;
- 4. All the directions issued by the Central Government of India vide Order No. 40-3/2020-DM-I(A) dtd. 29<sup>th</sup> July, 2020 and Order No. DMHS/COVID-19/2020/291 dtd. 31<sup>st</sup> July, 2020 issued by the Secretary (Health & Family Welfare), D&NH and D&D, shall be strictly complied with by all the persons.

This Order shall come into force immediately from the date of issue and shall remain in force till 31<sup>st</sup> August, 2020.

As this order cannot be served to all the persons, it has been put in the public domain for

information of the public at large.
