ORDER

Whereas, on the report of the Sub-Divisional Magistrate, Paonta Sahib, District Sirmaur (H.P.) dated 20th June, 2020, the left side area of Rampurghat road from Mata Balasundri Shop of Sh. Jaspal Singh upto Sabji Godown, from sabji godown to North-West side (Ashirvad Colony) upto Subhash Kariyana Shop, from Mata Bala Sundri Shop to South-West side (Guru Vihar Colony) upto Anant Ram House, falls in GP Kunja Matrallion and the area stretching from Pahadi colony to the house of Shanaz and from Pahadi colony to the house of Shokat Ali upto Shiv Mandir chowk was cordoned off and besides this area, entire office complex of Tirupati Medicare, Surajpur GP Patlion was sealed and Solvent Storage unit, parking area and oil station of Tirupati Medicare, Surajpur GP Patlion was declared as buffer zone, vide this office order of even No. dated 21th June, 2020.

Whereas, the Block Medical Officer, Rajpur has reported that all primary and secondary contacts of positive cases have been tested as negative and no new case of Covid-19 has been detected/identified in above mentioned areas. The said Medical Officer has further recommended that containment in above mentioned areas is not required to be continuing except Paying Guest House of Sh. Neeraj Verma situated at Ashirvad Colony opposite Shah Filling Station, Rampurghat, GP Kunja Matralion.

Whereas, the Sub-Divisional Magistrate, Paonta Sahib, District Sirmaur (HP) has also recommended vide his letter No. SDM-Paonta-SDK(COVID-19)2020 dated 07th & 08th July, 2020 that containment operation in above mentioned areas except Paying Guest House of Sh. Neeraj Verma situated at Ashirvad Colony opposite Shah Filling Station, Rampurghat, GP Kunja Matralion may be scaled down as

no new case of Covid-19 has been detected in the said areas even after the lapse of 17 days. Moreover, two persons after testing positive were shifted to covid care centre, Trilokpur and the samples of both persons were again collected on 25th & 27th June, 2020 and both were tested negative. After discharging from covid care centre, Trilokpur, both the persons have also completed the period of home quarantine. The Sub-Divisional Magistrate, Paonta Sahib has further reported that people residing in the said containment areas are getting problems to arrange essential commodities for their day to day requirement and the employees living in that areas also want to join their duties in their respective offices and accordingly requested the undersigned to scale down the containment operation in above mentioned areas.

Whereas, I am satisfied that since no new case has been identified from that areas mentioned above and all primary and secondary contacts of positive cases have been tested as negative District Magistrate Nattalerefore, with a view to mitigate the problems being faced by the people and employees of the said containment areas, the containment operation is not required for longer time in the said areas except the recommended one.

> Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur in exercise of the powers vested in me under Section 144(1)(5) of Cr.P.C. 1973 do hereby order and direct that:-

- The containment operation in areas mentioned above 1. (except Paying Guest House of Sh. Neeraj Verma situated at Ashirvad Colony opposite Shah Filling Station, Rampurghat, GP Kunja Matralion) as recommended by Sub-Divisional Magistrate, Paonta Sahib & Block Medical Officer, Rajpur is scaled down and thus refined.
- The order dated 29th June, 2020 of the Ministry of Home Affairs, Govt. of India, directions dated 30th June, 2020 of the Govt. of H.P. and the order dated 30th June, 2020 issued by this office shall remain enforced in the said area and all concerned shall ensure compliance of these orders.

- The movement of individual(s) shall remain strictly prohibited between 09:00 PM to 05:00 AM (Night Curfew) except for essential activities.
- 4. All orders issued by this office from time to time to contain the Covid-19 shall remain enforced and all concerned shall ensure compliance of these orders.
- All persons above 65 years of age and persons with comorbidities, pregnant women and children below the age of 10 years, shall stay at home, except for essential and health purposes.
- Wearing of face cover is compulsory in all public and work places.
- Spitting in public & work places shall be punishable with fine, as may be prescribed in accordance with laws, rules or regulations by the local authority.
- 8. All the shop keepers shall ensure minimum six feet distance (2 gaz ki doori) among the customers.

Any person violating these orders shall be liable for prosecution under Section 269,270 and 188 IPC and Section 51 to 60 of Disaster Management Act, 2005.

This order shall come into effect immediately from the date of issuance.
