Whereas, Novel Corona Virus Disease (nCOVID-19) situation has been declared as a notified disaster under the provision of Disaster Management Act, 2005, has prompted the District Administration to take several prevenive measures.

Whereas, the Government of Puducherry, after having satisfied that the Union Territory of Puducherry is threatended with the spread of COVID-19 virus, which has already been declared as a pandemic by World Health Organisation, has issued lock down orders with certain relaxations in order to sustain the state economy and livelihood of the citizens. However the relaxations of lockdown has resulted in the fast spread of COVID-19 virus which is seen in the number of sudden increase in the recent past.

And Whereas, after an elaborate discussion in the State Disaster Management Authority (SDMA) meeting held on 21.06.2020 and as per the directions of the Hon'ble Chairperson, SDMA, the following measures are ordered with effect from 23.06.2020 for the UT of Puducherry.

- 1. All shops, establishments (including liquor shops, petrol pumps) shall function from 06.00 AM to 02.00 PM only.
- 2. Milk booths shall operate 06.00 AM to 06.00 PM
- 3. The medical shops / pharmacy are permitted to be open without any restrictions.
- 4. Dining in Restaurants are permitted upto 02.00 PM. Restaurants are permitted to operat upto 08.00 PM for take-away only.
- 5. The beach in Karaikal is closed for 10 days with effect from 23.06.2020.

- This restriction is not applicable to Industrial / Agricultural / Fishing activities, Government Offices and Hospitals.
- Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years are advised to stay at home, except for meeting essential requirements and for health purposes.
- 8. Any person violating these measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, Epidemic Act, 1897 besides legal action under Section 188 of the IPC and other legal provisions as applicable.

The authorities shall comply with the above instructions.
