## OFFICE OF DEPUTY COMMISSIONER CUM DISTT. MAGISTRATE, FEROZEPUR (Misc. Branch)

ORDER No: 466

Whereas, in exercise of powers conferred under Section 144 of Cr.PC, certain restrictions were imposed in the district by order no. 465 issued vide endst. No. MA/MC-1/2020/1377 dated 18.05.2020 for the containment and prevention of the spread of COVID-19. Now, Ministry of Home Affairs, Govt. of India and Department of Home Affairs & Justice, Govt. of Punjab has issued fresh guidelines regarding lockdown for containment and prevention of Covid-19. Also, the Covid-19 situation has been improved in the district Ferozepur.

Therefore, I Kulwant Singh, IAS, District Magistrate, Ferozepur in exercise of powers conferred upon me under section 144 of Cr.PC and in supersession of earlier order no. 465 dated 18.05.2020 hereby order as follows:

- The movement of individuals shall remain prohibited between 09.00 PM to 05.00 AM, except for essential activities.
- 2. The persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years, shall stay at home, except for essential and health purposes.
- 3. The movement of medical professionals, nurses, para-medical staffs, sanitation, personnel and ambulances shall be allowed without any restrictions.
- 4. The timings for opening of shops shall be from 07:00 AM to 07:00 PM. However, the shopping malls shall remain closed. Barber shops, Saloons and Spas are allowed to open from 07.00 AM to 07.00 PM subject to compliance of guidelines issued by Health department from time to time. The timing for opening of liquor shops shall be from 08.00 AM to 08.00 PM.
- 5. All school, colleges, educational / training / coaching / institution shall remain closed. Online / distance / learning shall continue to be permitted and shall be encouraged.
- 6. Hotels, restaurants, other hospitality services, except those meant for housing health/police/govt. officials/health workers/stranded persons including to his and for quarantine facilities, shall be prohibited. Restaurants shall be permitted to operate kitchen for home delivery of food items.
- 7. All cinema halls, shopping malls, gymnasiums, swimming pools, entertainment parks, theatres, bars, auditoriums, assembly halls and similar places shall remain closed.
- 8. Sports complexes and stadia shall be permitted to open. However, spectators shall not be allowed.
- 9. All social / political / sports / entertainment / academic / cultural / religious / function / other gathering and large congregations shall remain prohibited.
- 10. All religious places and places of worship shall remain closed for public. Religious congregations shall be prohibited.
- 11. The Inter-State movement of passengers is allowed. The persons coming to the district from outside the State shall be required to download Cova App and get self generated e-Pass or declare their particulars at the entry of the district. The incoming persons shall be required to follow the SOP issued by Health Department from time to time.
- 12. The movement of all types of goods / cargo, including empty trucks shall be allowed.
- Taxis, Cab aggregators, Bicycles, Rickshaws, Auto-Rickshaws, Two-Wheelers, Four-Wheelers shall be allowed without any restrictions subject to compliance of SOP issued from time to time. The two wheelers are allowed to carry 1+1 passengers and the four wheelers are allowed to carry 1+2 passengers. The intra-state independent of passenger vehicles shall be allowed without any restrictions. However, the inter-state independent of passenger vehicles shall be permitted with self generated e-Pass ROZER.

- 14. Construction activities shall be allowed without any restrictions.
- 15. Agricultural, Horticultural, Animal Husbandry and Veterinary services shall be allowed without any restrictions.
- 16. E-commerce activities shall be allowed for all kind of goods.
- 17. Wearing of face cover shall be mandatory in all public and work places.
- 18. Spitting in public and work places shall be prohibited.
- 19. Social distancing shall be followed by all persons in public places and in transport.
- 20. Marriage related gathering shall ensure social distancing, and the maximum number of guests allowed shall not be more than 50.
- 21. Funeral/last rites related gathering shall ensure social distancing, and the maximum numbers allowed shall not be more than 20.
- 22. Consumption of liquor, paan, gutka, tobacco etc. in public places shall be prohibited.
- 23. All the shops shall ensure minimum six feet distance among the customers and shall not allow more than 5 persons at the shops.
- All the persons incharge of work places shall ensure social distancing through adequate distance between workers, adequate gaps between shifts, staggering the lunch breaks of staff etc. The practice of work from home should be encouraged. The provision of thermal scanning, hand wash and sanitizer shall be made available at all entry & exit points and common areas at the work places. The frequent sanitization of entire workplace, common facilities and all points which come into human contact shall be ensured. The staggering of work/business hours shall be followed in offices, work places shops, markets and industrial & commercial establishments.
- 25. Only essential activities shall be allowed in the areas notified as containment zones / Buffer Zones. There shall be strict perimeter control to ensure that there is no movement of people in or out of these zones, except of medical emergencies and for maintaining supply of essential goods and services.
- 26. No separate permission shall be required by the industries and other establishments to resume their operations. All employees, be it government offices, private offices and other work places, shall be allowed to move without any requirement of pass during the permitted hours i.e. 05: 00 AM to 09:00 PM. The employees shall be motivated to install Arogaya Setu App on their compatible mobile phones and also regularly update their health status on the App.
- 27. There shall be no restriction on inter-state movement of persons and no separate permission or e-Pass shall be required for such movement. However, the use of Cova App and self generated e-Pass shall be mandatory.

28. All the persons in the district are advised to install Arogaya Setu App on their compatible mobile phones and also regularly update their health status on the App.
