In this regard, it is informed that ESIC will conduct Health Check-ups in industrial clusters on regular basis w.e.f. 28th March, 2022. The purpose of regular health screenings at the workplace is to update employee about their health condition and encourage them to adopt a healthy lifestyle. Simultaneously, occupational health screening will also help to identify any of the ailments at an early stage so as to facilitate planning of timely and accurate treatment.

For the above purpose, following ESIC hospitals have been selected to send the team of doctors along with ancillary paramedical personnel and other staff and health check-up kits as per local need basis to industrial clusters as identified by the concerned RDs/SRO In-charge of the cities. The concerned RDs/SRO In-charges will be responsible for identification of such industrial cluster and providing space along with other peripherals. It is pertinent to screen all the employees of the identified cluster, before moving to the next cluster.
