No. Elec-2022/IR-II/PSCE/Hol/ 33028 Whereas the General election of the Panches, Sarpanch of Gram Panchayats, Member of Panchayat Samitis and Zila Parishads in the State of Haryana for which first phase poll shall be held on 30.10.2022 (Sunday) and 02.11.2022 (Wednesday) in the Districts namely, Bhiwani, Fatehabad, Jhajjar, Jind, Kaithal, Mahendergarh, Nuh, Panchkula, Panipat and Yamunanagar as per letter of the State Election Commission, Haryana issued vide letter no. SEC/4E-II/2022/3173-74 dated 07.10.2022.

And whereas, it is considered necessary to provide opportunity to the public to exercise their franchise.


Now, therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fixes "Sunday" the 30.10.2022 and "Wednesday" the 02.11.2022 to be the paid holiday for all shops and commercial establishments falling in the above mentioned Districts, where the election is going to be held on the above dates of Panches, Sarpanch of Gram Panchayats, Member of Panchayat Samitis and Zila Parishads only for those employees who are enrolled as voters in the aforesaid Districts to enable them to cast their votes.


