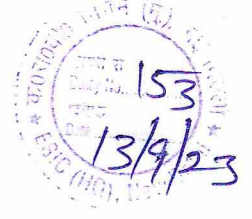

No. SS-II-SC-2/2021 8627 /LESI, Whereas by a notification of the Government of Odisha No.6365/ LESI dated 01.07.2023, the State Government, in consultation with the Employees' State Insurance Corporation and with the approval of Central Government vide Letter No.S-38025/07/2020-SS-I dated 09.06.2021, gave notice of its intention to extend the provisions of the Employees' State Insurance Act, 1948 to the classes of establishments specified in the schedule annexed hereto after one month from the date of publication in the Official Gazette.

And whereas the said notification was published in Odisha Gazette on 27.07.2023.


