Madam/Sir,

Please refer to this office letter no. No. U-13/14/SOM/ATR/38/21/Med.I dated 09.09.2022 and U-11/14/5/2015-Med (new services) dated 27.10.2016 on the subject of availing of medical services by ESI beneficiaries under the "Kahin bhi, Kabhi bhi" initiative.

1. In order to extend the portability in service delivery of ESIC on pan India basis, it has been decided that IP and beneficiaries may visit any dispensary/hospital across India for consultation and issuance of medicines through Dhanwantri module only, irrespective of the dispensary allotted on the beneficiary card.

2. In case of chronic disease patients medicines may be issued up to 90 days as and when required.

Accordingly, you are requested to take further necessary action for implementation as above.



Accordingly, it is re-iterated that compliance of aforesaid instruction is to be ensured so that such beneficiaries could avail medical services from any ESIC dispensary located in Delhi/Noida.

Sub: Availing of medical services by Delhi/ Noida ESI beneficiaries from any ESIC dispensaries located in Delhi/Noida under "Kahin Bhi Kabhi Bhi" w.e.f 1st November, 2016.

Sir/ Madam,

As you are aware, IPs and their families were earlier entitled to avail medical services from any ESI Hospital/ Dispensary under "Kahin Bhi Kabhi Bhi" which was withdrawn during 162nd meeting of ESI Corporation held on 31st July, 2014.

In this regard, in view of difficulties faced by IPs & their family members, the competent authority has approved re-introduction of "Kahin Bhi Kabhi Bhi" in Delhi/ Noida hospitals & dispensaries on a pilot basis w.e.f 1st November, 2016, as per following:

1. IPs and their families residing in Delhi/ Noida may seek primary medical care services, including consultation and medicines, for common / routine ailments from any of the ESIC dispensary in Delhi/ Noida.
2. Patient may be referred from any ESIC dispensary to any ESIC Hospitals in Delhi/ Noida for secondary care, if required.
3. Medicines for chronic ailments like Diabetes, Hypertension, Cardiac & Renal disease etc and Super Speciality Treatment will continue to be availed from parent ESIC dispensary, as per existing instructions.

Hence, you are requested to take further necessary action for implementation, as per above.
