NOTIFICATION

The 7th August, 2023

G.S.R. 79/C.A.27/1996/Ss. 40 and 62/Amd.(3)/2023.-In exercise of the powers conferred by sections 40 and 62 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act No. 27 of 1996), and all other powers enabling him in his behalf, the Governor of Punjab, after consultation with the expert committee, is pleased to make the following rules further to amend the Punjab Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2008, namely:

RULES

- (i) These rules may be called the Punjab Building and Other Construction Workers (Regulation of Employment and Conditions of Service) (Amendment) Rules, 2023.
 - (ii) They shall come into force on and with effect from the date of their publication in the Official Gazette.
- 2. In the Punjab Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2008 (hereinafter referred to as the said rules), in rule 260, in sub-rule (3), for the words, sign and figures "A certificate from the employer or the contractor in form-XXVII", the following words, signs and figures shall be substituted, namely:-

"A certificate, from the employer or the contractor or any other person or authority or officer who is authorized by the Board, in Form-XXVII".

3. In the said rules, in rule 261, in sub-rule (1), for the words and signs. "This contribution shall be remitted in advance once in three months in any of the banks, specified by the Board in the district, in which the member resides.", the following words, signs and figures shall be substituted, namely:-

"This contribution shall be remitted in advance for a period of one year at the time of applying for registration or renewal of registration in any of the banks, specified by the Board in the district, in which the member resides or in cash receipt (as prescribed in form no. XXXIV)".

4. In the said rules, for Form No. XXVII, the following Form shall be substituted, namely:-
