1. Introduction

It is essential for us in the Bunker One Group (“Bunker One”), that you as a co-operation partner feel comfortable with our processing of the personal data that comes into our possession when you do business with us. This policy on protecting personal data is a supplement to but does not replace, any other policies or terms and conditions that have been otherwise established between us.

2. Who is the controller of your personal data?

The Danish company, Bunker One A/S (“Bunker One”), is the controller of the personal data you submit to us within the Bunker One Group. Bunker One is responsible for your personal data under The General Data Protection Regulation (“GDPR”) and local laws.

3. Where do we store your data?

The data we collect from you is stored within the European Economic Area (“EEA”), but may also be transferred to and processed in a country outside of the EEA. Any such transfer of your personal data will be carried out in compliance with GDPR.

Companies within the Bunker One Group only transfer personal data to third countries (non-EEA countries), if certain conditions are complied with. A transfer may, for instance, take place if the EU Commission has decided that the third country in question ensures an adequate level of protection, or has provided appropriate safeguards, such as entering into an agreement comprising the EU standard contractual clauses with the recipient of the personal data or choosing a recipient that adheres to a specific adequacy scheme (such as EU-US Privacy Shield).

4. Who can access your data?

If the purpose requires it, your personal data may be shared internally in the Bunker One Group. We never sell or otherwise pass on your data to external third parties for marketing purposes.

5. What personal data is processed by us?

The BH Group collects and processes your personal data. The data we collect and process in given situations varies, but the personal data may be the following:

- Master data, including name, address, telephone number, date of birth, gender and e-mail address.
- Personal data sent to us in chats and/or e-mails for the legitimate interest of our relationship purposes.

Your personal data collected through the various technologies, channels and platforms may be combined. The primary legal basis for processing your personal data is to enter into a contract or before entering.

6. What is the purpose of the processing?

We process personal data in the Bunker One Group regarding employees, customers, vendors and other co-operation partners for business, financial and administrative purposes.

- The processing of personal data in the Bunker One Group is in accordance with the following principles:
- We only process personal data lawfully, fairly and in a transparent manner concerning the data subject
- We only collect personal data for specified explicit and legitimate purposes
- We only process adequate and relevant personal data, which is limited to what is necessary in relation to the purposes for which they are processed
- We make sure that personal data is accurate and kept up to date. Inaccurate personal data is erased or rectified without undue delay
- We delete personal data that is no longer necessary for the purposes for which the personal data were processed
- We ensure that personal data is processed in a manner that ensures appropriate security of such personal data.

7. How do we protect your personal data?

We use technical and organisational security measures to protect your personal data from manipulation, loss, destruction or access by unauthorised persons, or processing contrary to legislation. Our security procedures are regularly revised based on the newest developments in technology and threat assessments.

8. What are your rights?

You are entitled to receive information about and object to the processing of your personal data. Upon sending your request to Bunker One, you are entitled to have corrected, deleted or blocked any data that turns out to be incorrect or misleading or has been processed contrary to the personal data legislation.

Furthermore, you have the right to object to processing of your personal data that is based on the legitimate interest of the Bunker One Group. The Bunker One Group will not continue to process the personal data unless we can demonstrate legitimate grounds for the process, which overrides your interest and rights or due to legal claims.

9. For how long do we store personal data?

We don't store personal data in a manner that makes it possible to identify you for a longer period than necessary, considering the purpose of processing the data.

10. For how long do we store personal data?

If you consider us to process your personal data in an incorrect way, please contact us. You also have the right to raise a complaint to a supervisory authority.

11. Contact

We take data protection very seriously and therefore have a department in our mother company Bunker Holding A/S that handles requests in relation to your rights stated above in subject 8.

12. Use of External Data Processors (HubSpot)

We use HubSpot Inc. as an external data processor for handling marketing-related data, including email communication. HubSpot is a U.S.-based provider, and as part of our use of their services, certain personal data may be transferred to and processed in the United States.

Such transfers are carried out in accordance with the EU-US Data Privacy Framework, under which HubSpot is certified. The certification ensures an adequate level of protection for personal data transferred to the United States. HubSpot only processes personal data on our behalf and in accordance with our documented instructions.
