- Sealed bids must be received at Southeast Alaska Power Agency, 55 Don Finney Lane, Ketchikan, Alaska 99901 on or before **November 3, 2025** at 4:00 p.m. AKST in a sealed envelope marked "**Sealed Bid for Surplus Vehicle**", or Bidders may submit their bids electronically via email to [ContAdmin@seapahydro.org](mailto:ContAdmin@seapahydro.org) in.pdf format using direct computerized conversion to .pdf files and type ("Sealed Bid for Surplus Vehicle") in the subject line. To preserve legibility in reproduction, printing and rescanning shall only be used for the signing of documents or similar occurrences and only with the original document. All submittals shall be clear and legible for further reproduction by the Owner. Scanned copies of original signatures will be treated in all aspects as having the same effect as an original signature.
- The successful Bidder must make payment in full by cash, money order, cashier's check, or a certified check made payable to the Southeast Alaska Power Agency, within 48 hours of notice of the successful bid, and must remove the Surplus Vehicle from SEAPA's property within 24 hours of their receipt of an "As-Is, Where-Is" Bill of Sale from SEAPA for the Surplus Vehicle. In the event payment is not made within the time specified, the Surplus Vehicle will be offered to the next highest bidder.
- In the event of two (2) or more highest bids in the same amount, all equal bidders will be given the opportunity to place a second sealed or electronic bid of equal or greater value.
- SEAPA is not responsible for bids that are lost or delayed in transit. Late bids will not be considered. It is Bidder's responsibility to make sure their bid is timely received by SEAPA.
