

## Terms and conditions

### Art Gallery Members Travel and Luxury Draw 2023

1. Information on how to enter forms part of the terms and conditions of entry. Tickets for the Art Gallery Members Travel and Luxury Draw 2023 may be purchased by current members of the Art Gallery of Society of New South Wales (Art Gallery Society), online <http://secure.artgalleriesociety.org.au>, by phone (02) 9225 1878 or by visiting the Members Lounge at the Art Gallery of New South Wales (Art Gallery). Ticket prices are \$8 each, 5 tickets for \$35, 10 tickets for \$60, 20 tickets for \$100 and 35 tickets for \$140.
2. Permit No. GOCAU/2482 issued subject to the Community Gaming Act 2018 and Community Gaming Regulation 2020. Art Gallery Members Travel and Luxury Draw Art Union is in aid of the Art Gallery of Society of New South Wales. Number of tickets to be sold: 50,000.
3. The promoter is the Art Gallery of Society of New South Wales, ABN 26 000 207 198, Art Gallery Rd, The Domain NSW 2000, phone (02) 9225 1878. Employees and their immediate families of the Art Gallery Society and their agencies and companies associated with the promotion are ineligible to enter the Prize Draw.
