Terms and Conditions

Introduction

- 1. The Reece Group Foundation Limited (ABN 89 635 658 276) (**Foundation**) **Grant** is consistent with the Foundation's objects as set out in its Constitution.
- 2. Financial support under the Grant must advance the Foundation's vision.
- 3. Submitting an application for Grant funding from the Foundation shall be deemed an acknowledgement and acceptance of these terms and conditions (**Terms and Conditions**).
- 5. Submitting an application for Grant funding from the Foundation is free.

Who is eligible?

6. Grant funding may be awarded to any applicant who meets the Assessment Criteria as outlined <u>here</u>, except employees and immediate families of the Foundation and any member of the Reece Group of companies. (**Reece**).

Grant Review Process

- 7. Each submission is reviewed and assessed by the Reece Foundation Team within 4 weeks of the application close period.
- 8. Incomplete Applications will be automatically withdrawn and not considered for the requested funding period. It is the responsibility of the individual applying for a grant (**Applicant**) to ensure all required documentation is included in the application (**Application**).
- 9. Unsuccessful Applicants will be notified via email within 4 weeks of the application close period.
- 10. Successful Applicants will be notified via phone and email of their successful application within 6 weeks of the application close period.

Grant Application Process

- 11. An Application is completed online.
- 12. An Applicant must complete an Application Form found on the Foundation's website.
- 13. Applicants acknowledge that their online Application is only received by the Foundation when they receive a pop-up confirmation on the Application form. Applicants will also receive an email notification of the form submission.
- 14. Applicants must acknowledge that they have read the Terms and Conditions by accepting the Terms and Conditions on the submission page.

Acknowledgement, warranty, and indemnity

- 15. By accepting the Terms and Conditions:
 - a) Those Applicants who submit a video and/or any photographs with their Application warrant that they:
 - 1. are the author of the Application that they submit;
 - 2. have the authority to submit the video and/or photographs for the purpose of consideration for a grant;
 - 3. have the right to grant the Foundation permission to use the video and/or photographs, have obtained consent from individuals/groups featured in imagery; and
 - 4. such use will not breach any third party intellectual property rights.
 - b) Applications submitted may be entered into a database for future promotional, marketing and/or publicity purposes.
- 16. Reece and the Foundation accepts no responsibility for late, lost, misplaced, or misdirected Applications
- 17. Except for any liability that cannot be excluded by law, the Foundation will not be liable for any failure to submit an Application where such a failure arises out of any technical difficulties or equipment malfunction (whether or not under the Foundation's control).
- 18. The Foundation is not liable for any costs, expenses, loss, or damage incurred by the Applicant, including but not limited to direct or consequential loss, or personal injury suffered or sustained in connection with the Application, including required documentation, irrespective of whether the Application is successful or not.

Availability of Grant Funding

16. Applications for Grant Funding will be reviewed on a quarterly basis (or such other frequency as determined by the Foundation from time to time) and the number of successful Applications will be subject to funds raised for the Foundation at the point in time. Accordingly, Grant Funding may not always be available and may vary throughout the year.
